Students march in support of "Shannen's Dream"

Chapleau Public School students marched in support of "Shannen's Dream".

Shannen Koostachin was a youth leader in Attawapiskat. She came to national attention through her struggle to get the federal government to build a school in her James Bay community.

MAKE YOUR **VOTE** COUNT! Last May, Shannen died in a tragic road accident.

For eight years the children of Attawapiskat had been going to school in poorly constructed portables. The failure of the federal government to follow through on a promise to build a "real" school ignited a determination in Shannen and her fellow students to bring this to the attention of the world. Shannen was in Grade 8 at the time and became an inspirational force in getting students from school boards across Canada involved in a letterwriting campaign to change conditions for the children of her community.

In 2009, the federal government promised the children of Attawapiskat a new school. It is November, 2010 and the school has yet to be built.

The Ontario Public School Boards' Association has joined with First Nations organizations, with teacher federations and with other education partners to advocate not only for the community Attawapiskat but for fair and equitable education funding for all First Nation communities.

"Canadians want the best for Aboriginal children and their families." said Catherine Fife, president of the Ontario Public School

Boards' Association. "Children should have a continuum of consistent, equitable and high quality educational experiences regardless of where they live in Canada. This is not only a key to success but a basic human right."

Shannen's Dream is a campaign named in memory of a courageous young woman who sparked a passion to make sure all First Nations children across Canada have decent schools and the kind of education that makes them proud of who they are.

On Wednesday, November 17, a media conference to honour 'Shannen's Dream' took place in Ottawa. Through a

webcast, students from Attawapiskat brought greetings to the students of Elgin Street Public School. Youth Panel flew to Ottawa from Attawapiskat to describe what it is like to go to school in make-shift portables.

At the media conference, Shannen Koostachin was recognized posthu-

mously through the Children's Rights Award from the Canadian Coalition for the Rights of Children. The award recognizes individuals or groups who demonstrate exemplary efforts to respect the rights of children as described in the UN Convention on the Rights of the Child. It was presented to Shannen's parents.



Chapleau High School sees new principal and teaching staff in 1961 as it starts to experience baby boom effect as enrolment zooms to 200 students

When students returned for classes at Chapleau High School in the Fall of 1961, they were greeted by a new principal and new teaching staff with the exception of Mrs. Gladys Bowles who had been there for several years.

The student population had also zoomed from 136 to 200 as CHS began to experience the "baby boom" effect.

Luther Emerson was the new principal while 1961 also marked the arrival of George Evans, who would be at CHS until 1989 when he retired as History and English

teacher, and assistant principal.

With the increased enrolment, the commercial classroom was moved into the old assembly hall, but physical education classes were still held in the low ceiling gym.

The school newspaper "News and Views" with Susan Cecile as editor, noted that Grade 11 was considered "a very important class" with no real explanation given as to why it was, other than adding that "among its ranks were Shirley Petrunka, Howard Higuchi, David Futhey, Bill Fox

and the vice president of the Students Council Gary Schafer. The class rep was Phyllis Fournier".

Shirley Petrunka and Barbara Gervais were assistant editors of the school newspaper.

At the annual commencement, Alex Babin received his intermediate certificate. Upon graduation, Alex attended Laurentian University where he received his Bachelor of Arts degree, and returned to teach at CHS and serve as staff advisor to the Students Council for many years. With Margaret



On April 15th and 16th, the Chapleau High School (CHS) Envirothon Team participated in the 2011 Algoma Region Envirothon Competition at Kinsmen Park in Sault Ste. Marie.


