Important Chapleau Minor Hockey annual meeting to be held at the end of this month

Chapleau Minor Hockey Association will be holding its annual meeting Tuesday April 27, at 7pm at the curling rink lounge. CMHA is hoping to encourage better attendance by holding the meeting a few weeks earlier than in previous years.

This meeting is open to anyone involved with minor hockey over the past season or interested in becoming involved for

the coming season. That includes parents of players, members of the current executive and anyone interested in a position with the coaching staff of any team or on the executive.

The agenda for the meeting includes review of the minutes to the 2009 Annual Meeting and discussion of any business arising from the minutes; review and acceptance of reports for the 2009/10

season; discussion of any new business items; proposed amendments to the constitution; election of executive positions and election of head coach for each team. It may seem like a long agenda but the meeting usually takes no longer than two hours.

Any proposed amendments will be reviewed and discussed at the meeting. A motion and second from those present is required before being

voting on each of the proposed amendments by all present.

This year all executive positions are up for election. President, 1st vice president, 2nd vice president, treasurer and secretary are two-year positions. Public relations director, equipment convenor and Initiation director are one-year positions. The Executive also includes the referee-in-chief, appointed from the group of

referees at the start of the season and the past president. Nominations for any position are accepted at the meeting. Each nomination must be seconded to be eligible for voting.

Elections are also held for head coach positions for any of the teams – Initiation, Novice, Atom, Pee Wee, Bantam or Midget. Anyone interested in a head coach position must submit a letter of

qualifications with signatures of five parents of players or current executive members. This letter may be submitted at the meeting.

Your participation at this meeting, or consideration for a position in the executive or as a coach is important to the future success of minor hockey in Chapleau. Minor Hockey needs your support. Please plan to attend!

Forest fire situation update

There have been no new fires in the East Fire Region since April 16. The fire hazard in the region is mostly low but moderate to high in the Sault Ste. Marie, Sudbury and Parry Sound areas.

April 18th to 24th is Wildfire Prevention Week. This year's theme is Wildfires Cost You.

Due to low snowfall amounts and warm, dry weather in March, many areas of Ontario are snow free. Wind can quickly turn grass and brush burns into wildfires.

With the spring weather, many people begin cleaning dead vegetation and debris from their homes, camps and cottages.

Composting, chipping or removal to approved disposal facilities are safer options than burning.

If found responsible for a wildfire, a person can be charged under the Forest Fires Prevention Act and/or be liable for the costs of suppressing the fire. Suppression costs can

easily run into the tens of thousands of dollars. Additionally, neighbours that suffered loss of values due to fire may seek compensation. The Ontario Ministry of Natural Resources responds to an average of 1160 wildfires per year. Municipalities across Ontario respond to hundreds more.

So far this year in the East Fire Region, there have been 34 fires burning over 209 hectares.

310-FIRE (3473) is the new, toll-free emergency forest fire reporting phone number across northern Ontario.

Early detection and reporting are essential to quickly managing forest fires. Having one number

will make it easier and more efficient for Ontarians to report forest fire emergencies. The number will operate north of the French and Mattawa Rivers.

availability of more affordable drugs.

You may be wondering what this reform means for pharmacies in our area.

I want you to know that our government values pharmacy services in rural and underserved areas. That is why we're devoting additional funding to ensure that the pharmacies in these communities can continue providing quality services that their customers depend on. This funding would come in three ways: By increasing dispensing fees by up to \$4 for every Ontario Drug Benefit prescription rural and under-served pharmacies fill; By compensating pharmacies directly for the professional services pharmacists provide to patients; By creating a specific fund to support pharmacies in rural and under-served areas.

The changes we're making to Ontario's drug system are about getting better value for taxpayer dollars. Currently, Ontarians are paying too much for generic prescription drugs—in certain cases more than five times what some U.S. states pay.

That's why the

McGuinty government is reducing the price of generic drugs by at least 50 per cent. This will have big benefits for consumers who pay for their drugs out-of-pocket, people who have a drug plan through their employer and people who use Ontario's public drug programs.

Here's an example of how the changes our government is making will make drugs more affordable for someone without a drug plan: once our reforms take full effect, a woman who pays for a generic birth control pill out of her own pocket could save more than \$80 every year. At the same time, someone who takes Ramipril, a generic drug used to treat high blood pressure, could save more than \$160 a year once the changes are complete.

We're securing lower drug prices and meaningful savings for Ontarians, but not at the expense of pharmacy services in rural and underserved areas of the province. Our government will ensure continued access to pharmacy services in these communities by increasing dispensing fees for pharmacies, adding more funding

Jamie Thibault recalls importance of laughter at high school while Chapleau summer activities get underway in 1976

Jamie Thibault, who was president of the Students Council at Chapleau High School in 1976-77, reflected on the importance of laughter as part of everyday life at the school when he was attending it in the Seventies.

Writing in the souvenir newspaper for the school's 75th anniversary in 1997, Jamie says that while laughter was never really given the respect it should have received, "it was a something, a quality perhaps, that everyone possessed whether they were aware of it or not."

Reflecting on his high school days Jamie still heard laughter in the hallways, classrooms, gymnasiums, library, on the hill as students told jokes. passed along secrets, and pulled pranks amongst one another.

"I hear the comic anecdotes of

Mr. (Bryan) Kuehl to drill home a point in his Biology class; I relive the hockey tales from Mr. Morris in Man and Society; I visualize the comical actions that Mr. (Alex) Babin used to illustrate the use of a verb in French class: I hear Mr. (George) Evans using comic relief to get the class through another session of Greek mythology; I hear Mr. (Ross) Hryhorchuk laughing at another display of comic athletic prowess..."

On the 1976-77 CHS Students Council with Jamie were Tom O'Shaughnessy, Willie Date, Tim Morin, Jean Doyle, Francois Tremblay, Elaine Travis, Mike Serre, Joan Payette and Anne Marie Payette.

RECREATION ACTIVITIES UNDERWAY

Meanwhile, in the Spring of 1976, recreation activities were getting underway for the summer season.

Little League Baseball was getting underway at Grinton Park, where the Chapleau Recreation Centre opened in 1978, and with repairs to the field having been completed, under the capable guidance of president Bill Chambers, Chapleau would be hosting the District Four Little League playoffs.

At the beach Paul Richardson would be returning for his second year as the swimming instructor and lifeguard.

Over at the Chapleau Memorial Community Arena, the newly formed men's ball hockey league was getting underway with four teams participating -- Chapleau Lumber, The Hustlers, Ministry of Natural Resources and the West Side Boys.

In the opening

games, the Ministry of Natural Resources squeaked by Ron Larcher's Hustlers, scoring in the dying seconds to win 5-4. Chapleau Lumber built up a 3-0 lead but couldn't hold it and lost by an identical score to the West Side Boys. I remember attending the ball hockey league games and found them so relaxing after a long winter of coaching the Chapleau Intermediate "A" Huskies in their first season in the Northland Intermediate Hockey League in 1975-76. I sat in the stands and enjoyed the ball hockey games.

75th ANNIVERSARY PLANS FINALIZED

In the Spring of 1976, plans were also being finalized for Summerfest and Old Home Week to mark the 75th anniversary of the incorporation of Chapleau as a municipality to be held from July 1 to 4. Led by Festival Chapleau co-ordinator Eileen McCrea, a group of volunteers was working to finalize the activities -- and bring the circus tent to town for activities in the beach area.

Manlio Spessot and the Boy Scouts were organizing the canoe and kayak races while Dorleen Collings, who was often fondly called "Chapleau's cook" was planning the menus for the meals that would be provided. Recreation

Director Terry Bryson was overseeing all the recreation activities for the celebration.

Plans were also being made for a visit to Chapleau by the Hon. Rene Brunelle, chairman of the provincial cabinet, who would participate in the sod-turning ceremony for Cedar Grove Lodge for Senior Citizens which would be located on the old separate school site on Pine Street. During Senior Citizens Week, the Chapleau Senior Citizens Club saw plans for the new complex and made their comments.

Terry Bryson announced that a picnic for senior citizens would be held during the Old Home Week, while Councilor Ernie Gilbert outlined grants for Senior Citizens centres.

CENTENNIAL MUSEUM OPENS FOR SUMMER

Robert Andras, who was the minister of Manpower and Immigration for

Canada was in town in June and officially opened the Chapleau Centennial Museum for the summer season by raising a new Canadian flag on behalf of Prime Minister Pierre Trudeau.

Under the capable supervision of Dorleen Collings, The Chapleau Sentinel reported that the museum had been a "beehive of activity with flowers blossoming and the fountain "spattered with the pennies of those seeking luck." Inside many displays were being restored. The rock collection, stuffed birds and animals and the famous Rotary table were all in place.

National Immunization Awareness Week—April 24 To May 1

History has proven that immunization saves lives. A century ago, many children never saw their fifth birthday due to diseases that could have been prevented by immunization. Almost all of those same diseases still exist, but today we have immunizations, and survival rates are much higher and diseases rates are significantly lower.

“For National Immunization Awareness Week, we're

encouraging everyone—not just parents of young children—to learn more about protecting themselves against vaccine preventable diseases,” said Lisa Schell, a manager in the Sudbury & District Health Unit's Clinical Services division.

The Canadian Immunization Guide recommends immunization beginning at two months of age and continuing through all stages of life. By

following a standard schedule for immunizations, people can receive the maximum protection that immunizations offer.

Where previous generations of Canadians were threatened by a range of serious diseases, we now have easy access to vaccines that have eradicated smallpox globally, eliminated polio in our part of the world, and greatly reduced the number of cases of other diseases like

whooping cough, measles, rubella, diphtheria, meningitis, and hepatitis B. Immunization has saved more Canadian lives than any other health intervention.

Although receiving immunizations during childhood is critical, some vaccines will not provide lifelong immunity against some diseases such as tetanus (lockjaw). A tetanus booster is recommended every 10 years. Tetanus is

caused by bacteria that live in dirt, dust, and manure. It can cause painful muscle spasms and convulsions, and can lead to breathing failure and death. The vaccine is publicly funded and provided at no cost to individuals.

Along with immunization information, the Health Unit will be providing tetanus vaccinations at the following local garden centres for adults who are due for this immunization:

Semaine Nationale De Promotion De La Vaccination – du 24 avril au 1er mai

L'histoire récente montre que la vaccination sauve des vies. Il y a cent ans, beaucoup d'enfants n'atteignaient par leur cinquième anniversaire à cause de maladies qu'on aurait pu éviter par vaccination. Presque toutes

ces maladies existent encore dans le monde, mais grâce à la vaccination, les taux de survie sont beaucoup plus élevés et les taux de maladies sont significativement plus faibles.

« Durant la Semaine nationale de

promotion de la vaccination, nous encourageons le grand public et pas seulement les parents de jeunes enfants – à se renseigner sur la façon de se protéger contre les maladies évitables par vaccination », a déclaré Lisa Schell,

une gestionnaire de la Division des services cliniques du Service de santé publique de Sudbury et du district.


Le Guide canadien d'immunisation recommande que le programme d'immunisation commence à l'âge de deux mois et se poursuive durant toutes les étapes de la vie. C'est en adhérant à un horaire standardisé d'immunisation que les gens peuvent obtenir la protection maximale offerte par l'immunisation.

Alors que les générations précédentes de Canadiens

étaient menacées par une série de maladies graves, nous avons maintenant accès à des vaccins qui ont éliminé la variole dans le monde, éliminé la poliomyélite dans notre partie du monde, et considérablement réduit le nombre de cas d'autres maladies comme la coqueluche, la rougeole, la rubéole, la diphtérie, la méningite et l'hépatite B. L'immunisation a sauvé la vie à plus de Canadiens que toute autre intervention du domaine de la santé.

Bien que les vaccins administrés durant l'enfance

revêtent une importance capitale, certains vaccins ne procurent pas une immunité permanente comme le vaccin contre le tétanos. Un vaccin de rappel contre le tétanos est conseillé tous les dix ans. Le tétanos est causé par une bactérie qui vit dans la saleté, la poussière et le fumier. La maladie peut entraîner des spasmes et des convulsions musculaires, un arrêt des fonctions respiratoires et la mort. Ce vaccin est administré gratuitement et est subventionné par le gouvernement.

Economic Growth Act Not Addressing Current Challenges

Carol Hughes was actively pointing out challenges that the recent federal budget did not address during debate on the Economic Growth and Jobs Act yesterday. Rising numerous times during debate,

Hughes highlighted the budgets omissions on Employment Insurance, job creation, pensions, the woefully inadequate increase to the child tax credit, and the bleak future we are offering today's youth

with our environmental failures.

"The budget does not provide (a mechanism) for extending the benefit period for the unemployed," said Hughes. "What is more, there is no additional funding for creating jobs. Nor is there anything to make access to employment insurance easier for women."

Hughes did not limit her criticism to the government's inadequate plan for employment. She

brought up the increasing difficulty faced by seniors who have seen their retirement plans fizzle as a result of non-performing pension plans made all-the-worse by inadequate government benefits.

"The budget does not address the crisis facing the pension system. There is no agency to pick up orphaned pension plans," stated Hughes. "There is no extension for CPP or QPP benefits, and no increases to GIS payments. The government refuses to

invest about \$700 million every year to lift our seniors out of poverty. There is no protection in place for pensions when the employer goes bankrupt."

Hughes also singled out the miniscule increase to the child tax credit and the abandonment of environmental measures, such as the federal Environmental Assessment Act, which amount to a betrayal of youth and families in the budget.

"With respect to the Conservatives not

getting up and talking on this issue, I can understand why they do not want to get up. They are probably ashamed of the fact that they are only giving \$3.25 a week as part of an increase in the child tax credit and they consider that to be a child care subsidy," Hughes remarked.

"Talk about the environment and what is in this bill, or more so, what is not in the bill, and how this will impact on the youth of this country, because they are our future" Hughes concluded.



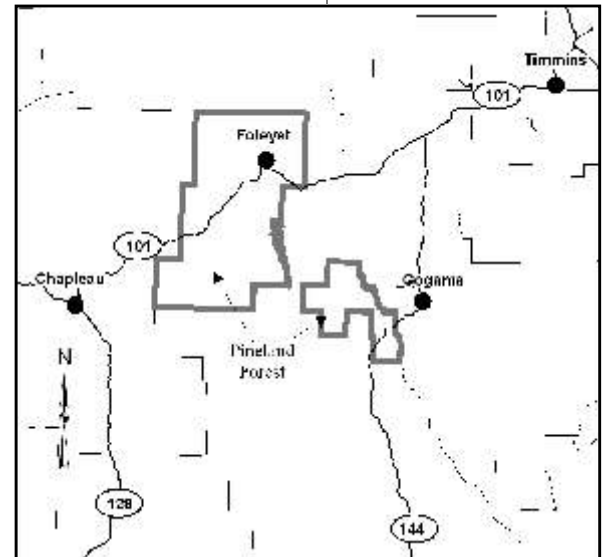

Protecting your Assets

Now more than ever, business owners are concerned about protecting their assets. When you invest so much time and effort into your businesses, it is critical to plan ahead before problems arise. Although insurance coverage can be obtained to protect against many business risks, some risks may not be fully or even partially covered.

There are many different ways of protecting your business and personal assets. A few of the available strategies are as follows:

Incorporate your Business – As a sole proprietor or unincorporated partnership, your personal assets, such as your investments, home, cottage, RRSP and other personal assets are at risk should business

creditors or others file legal claims against you. In addition to creditor-proofing, incorporation can also provide significant other benefits to you including significant tax savings or deferrals.

Use Multiple Corporations – Depending on the size and type of business, different business structures can help to protect your company's assets. The use of a holding company is one example of a useful tool to protect your company's accumulated equity. This structure is beneficial when your company begins to accumulate equity and involves a holding company owning the shares of an operating company. Since most inter-corporate dividends can be paid tax-free, the operating

company can declare dividends to the holding company to eliminate any equity in the operating company. The holding company can then invest the dividend proceeds and these funds are now protected against creditors of the operating company. If required, funds can be loaned back to the operating company on a secured basis.

Other uses of multiple companies involve holding significant business assets, such as land and building or equipment in a separate company and renting or leasing these assets to the operating company, or having different divisions operate out of different corporations. In the event of a financial crisis with the operating company, or one of the divisions, the assets of the other corporations would be protected.

Secure your Loans – If you are loaning funds to other businesses, or perhaps even to one of your operating companies, ensure to take back security. This can be

accomplished through a general security agreement whereby the company essentially pledges all of its assets as security for the loan or a mortgage over specific assets. For this strategy to be effective, the security agreements should be prepared by a lawyer and the security interest should be registered.

There are a variety of reasons why business owners do not use asset-protection strategies in operating their business. Many times it is due to cost or perhaps not wanting to complicate the corporate structure. Other times, business owners simply do not realize what is at stake should a disaster occur. One thing to remember is that any structure or plan to protect your assets is most effective when it is put in place when there are few assets and no outstanding claims against the company. If a claim is made against your company, by that time it is usually too late to do anything about it.

Proper planning and structuring of your business will help

to protect both your business and personal assets. There are many options and strategies available, but the best advice is to speak with your Accountant and lawyer to determine which are most appropriate in your particular circumstance.


