2008 "Tree of Lights"

On Friday, November 28, 2008 at 8:45 am, the 2008 "Tree of Lights" was lit. The student body and staff at Chapleau High School participated in the singing of O'Canada followed by an explanation of the purpose of the tree by Mrs. Nicolle Schuurmann. She

stated that this was the 13th year for lighting the tree, and this year it is in honour of volunteers. Pastor Dan Lee spoke on behalf of "Meals of Hope", a community based food bank that served 97 families from January to November in 2008.

"Meals of Hope" will receive half of the proceeds from the sale of the tree's bulbs. It is located at the Chapleau Pentecostal Church which is simply used as a storage and distribution facility for this service. He stressed that "Meals of Hope" is non-

denominational and is for any citizen in Chapleau and the surrounding area who requires help. Besides being a food bank, it also distributes good, clean clothing free of charge to those requiring it and offers free meals all 52 Mondays of the year between 11:30 am and 1:00 pm.

Following this, Mrs. Cheryl Boucher spoke about the importance and impact of volunteering and thanked the citizens of Chapleau who volunteer their time to many activities in the town and staff members who commit many hours outside of

their teaching duties to coaching and running the many clubs in the school. A thank you was extended to Mr. Don McEachren for his help throughout the school year and to three very special volunteers at Chapleau High School: Mrs. Hilary Arsenault and Mr. Rick Dell for their countless hours with the Drama Club and Mrs. Anne Gouge for the time spent behind the scenes in the cafeteria. The 2008 "Tree of Lights" was then lit by Hilary Arsenault and Amberly Quakegesic, Rick Dell and Cassandra Comte, Anne Gouge and Leanna Frappier; and

Pastor Dan Lee and Stephen Lee. Mrs. Nicolle Schuurmann concluded the ceremony by thanking the Chapleau Public Utilities Corporation, in particular Jonathan McEachren and Devin Smith, for maintaining our tree. Everyone then headed to the cafeteria to finish the ceremony with hot chocolate before heading to class.

Students' Council members (sporting a badge for identification) are selling the bulbs on the tree door to door for \$5.00 each or bulbs may be purchased through the mail - PO Box 880, Chapleau, ON. Include your

name and a list of names for whom the bulb(s) is in honour/memorial of.

REPORT from OTTAWA by Carol Hughes

It is no coincidence that the economic update delivered in the House of Commons on Thursday resembled the work of Mike Harris' Conservative Governments in Ontario. Many of the

principles involved, including the Finance Minister, came from Mr. Harris' government. And they are showing the same penchant for throwing partisan political solutions at problems that only highlights their misunderstanding of the real challenges Canada faces.

At a time when fiscal restraint is needed, Canadians must be scratching their collective heads as to how the government can afford billions of dollars in corporate tax cuts and would even consider selling valuable assets in a depressed market. These actions indicate that the Conservatives are more content to take care of their friends than to improve the well being of Canadian families

If, as Mr. Flaherty suggests, the government saw the current economic climate coming for quite some time, why didn't they sock away a few extra bucks while the sun was still shining instead of cutting off our ability to stimulate the economy from a position of strong budget surpluses? Yesterday's tax giveaways have become today's economic handcuffs.

The government's announcement was supposed to be about economic

stimulus, but we heard nothing of the sort in Mr. Flaherty's speech. Canadians are right to be leery about this and the do-nothing Throne Speech we saw a little over a week ago. To use a hunting analogy, they set out for bear and came back with partridge. Hardly the bold steps that are needed to prevent worst-case scenarios in uncertain economic times.

There are giant holes in the government's economic update. There is not one word on the

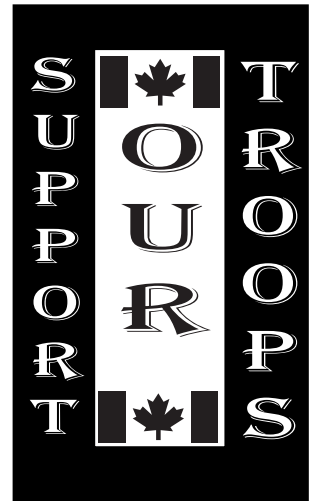
environment or about First Nations communities. No language that deals with forestry or EI reform. Very little for the manufacturing industry or a made-in-Canada procurement policy that would help protect Canadian jobs. No mention of a commitment to reduce poverty or review CPP, Old Age Security or Guaranteed income supplement to ensure that our seniors who helped build this country can feel secure in their retirement.

What is

included in the economic update? Combative language toward women on long-standing pay-equity disputes. Combative language directed at the Public Service, which includes those same people who police and protect us such as our military and the RCMP.

Although Mr. Flaherty likes to talk about families, there was nothing in the speech to assist them. Once again, the concerns of the boardroom table have won out over the

concerns of the kitchen table. The Conservatives have completely ignored the needs of Canadians and communities in their haste to make partisan attacks.

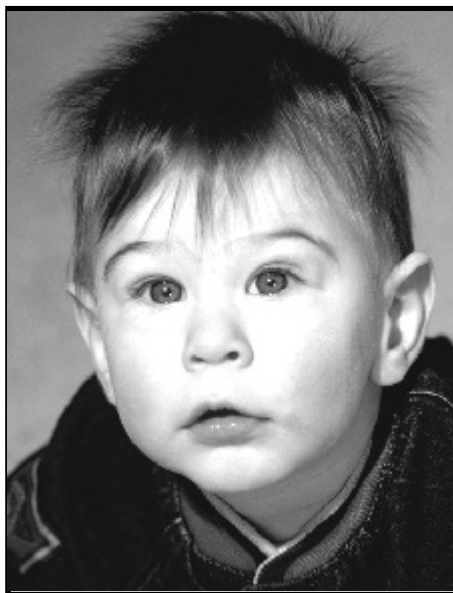

Hosting Christmas Dinner? Planning ahead will reduce stress.

(NC)—Christmas is tomorrow but the turkey is frozen solid. More than half of cooks surveyed began thawing 1-2 days before Christmas – That's far less than the four days recommended by the Butterball Turkey Talk-Line. Thaw more quickly by submerging the turkey in cold water. Leave the bird in the wrapper, place it breast down in a tub or sink of cold tap water. Allow 30 minutes per pound.

Don't have a roasting rack? Butterball recommends using a flat rack so the turkey is raised off the bottom of the pan to help it cook evenly. If you don't have a flat rack, place two or three large carrots underneath the bird.

New recipe, new pan? Always test out a new recipe or roasting pan before the big day arrives. This will prevent surprises like the turkey doesn't fit in the pan or the pan doesn't fit in the oven.

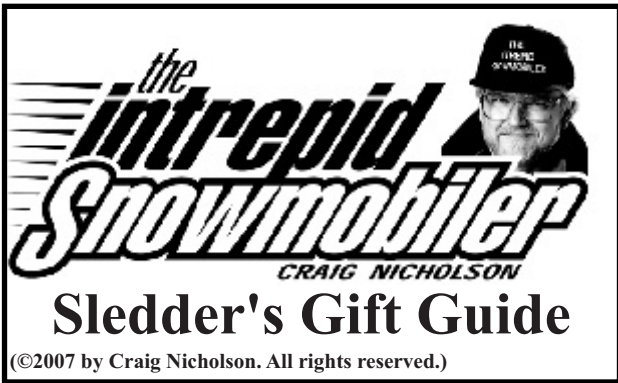

Turkey with Wine-Simmered Fruit Stuffing

(NC)—Dried apricots, cherries and raisins simmered in wine and combined with oatmeal bread and pecans.

Prep Time: 40 minutes

Total Time: 4 1/2 hours (approximately)

10 diced, oatmeal bread slices

1 cup 250 mL white wine

1 large Granny Smith apple

1/2 cup 125 mL chopped, dried apricots

1/2 cup 125 mL golden raisins

2 tbsp 30 mL butter

1 cup 250 mL chopped onion

1 cup 250 mL chopped celery

1/2 cup 125 mL chopped, toasted pecans

1/2 tsp 3 mL salt

1/4 tsp 1 mL coarse black pepper

1 1/2 cups 375 mL chicken broth

1 Butterball Turkey (15 lb/6.8 kg)



Directions:

1. Preheat oven to 325°F/165°C. Spread bread on bottom of shallow baking pan. Bake until browned (20-30 min) stirring occasionally.

2. Place wine, apples, apricots, cherries and raisins in a saucepan. Bring to a boil on high heat. Reduce heat and simmer for 5 min until wine is absorbed. Remove from heat and cool slightly.

3. Melt butter in large skillet. Add onion and celery. Cook and stir for 8 min until tender. Remove from heat.

4. Add fruit mixture, pecans, salt and pepper to skillet and stir.

5. Place mixture in large bowl and add bread and broth.

6. Prepare turkey as per package directions.

7. Place turkey, breast side up, on a flat rack in a shallow baking pan.

8. Fill neck and body cavities with stuffing. Rub turkey with vegetable oil. Place a small piece of foil over skin of neck cavity and over exposed stuffing.

9. Roast for about 4 1/2 hours, or until thermometer reaches a minimum 165°F/75°C in the center of the stuffing and 180°F/83°C deep in the thigh. Note: Cover lightly with foil after 2 1/2 hours to prevent over cooking the breast.

10. Let turkey stand for 15 minutes before removing stuffing and carving.

Ontario Weather Review: November 2008

The early sales of shovels and snow blowers may have brought a smile or two to some retailers in Ontario, what with significant snowfall making an abnormally early appearance. Considerable amounts of snow fell in traditional snow-belt areas, so a table of high single-day totals for Ontario is part of this report. In some cases, more snow fell in one day than would normally fall during an entire month. These large snowfall amounts resulted in the highest monthly totals for London since 1970 and for Sault Ste. Marie since 1989.

The snowfall in these areas brought their monthly precipitation – that is, the combined amounts of rain and snow – to high levels as well, but generally the rest of the province had near-

normal precipitation levels or even drier-than-normal readings.

Temperatures for Northern and Central Ontario were on the warm side this past month, with some locations reporting temperatures 2 to 3 degrees above normal. The rest of the province was near normal or slightly warmer than normal.

Severe Weather

While not really qualifying as severe weather, the stretch of record-breaking warmth and sunshine that occurred in many localities across the province from November 3-7 was definitely noteworthy. A number of single-day records for high temperatures fell during this period in both Northern and Southern Ontario. Aside from record-breaking temperatures, the

warm breezes from the southwest were also accompanied by lots of sunshine. November is usually known as a month where cloudy conditions dominate. So, a totally sunny day is a bit of a rarity – let alone being able to string three or more consecutive days of sunshine, as some areas did during this period near the start of the month.

Then, as if to remind us that it was November and not September, Mother Nature brought cold air back with a vengeance.

Temperatures plummeted across the province just past the mid-point of the month, with many areas experiencing overnight temperatures more than 10 degrees colder than normal. The coldest areas were in

Northwestern Ontario and to the north of Lake Superior, where overnight temperatures bottomed out between minus-21 degrees Celsius and minus-25 during the early morning hours of November 21 and 22.

This influx of arctic air was a perfect set-up for the lake-effect snow engine for regions in and around Sault Ste. Marie, as well as in the traditional snow belts in Southern Ontario near Lake Huron and Georgian Bay. Lake-effect snow events in late November and early December can be particularly powerful, given the marked contrast between the cold air flooding down from the northwest and the relatively much warmer waters of the ice-free Great Lakes. Forecasters in the Ontario Storm Prediction Centre in Toronto realized that the snow squalls generated over Lake Huron and Georgian Bay on November 20 and 21 had the potential to dump massive amounts of snow...leading to words like “colossal” being mentioned in the snow squall warnings for some areas. One particularly intense and long-lived band of snow came in off Lake Huron late on November 20 and persisted into the early morning hours of November 21. It dumped some 75 centimetres of snow in communities in Northeastern Lambton County, just south of Pinery Provincial Park. These huge accumulations led to the temporary closure of Highway 402 between London and Sarnia and a number of people stranded in their vehicles required rescue by the Ontario Provincial Police aboard snowmobiles.

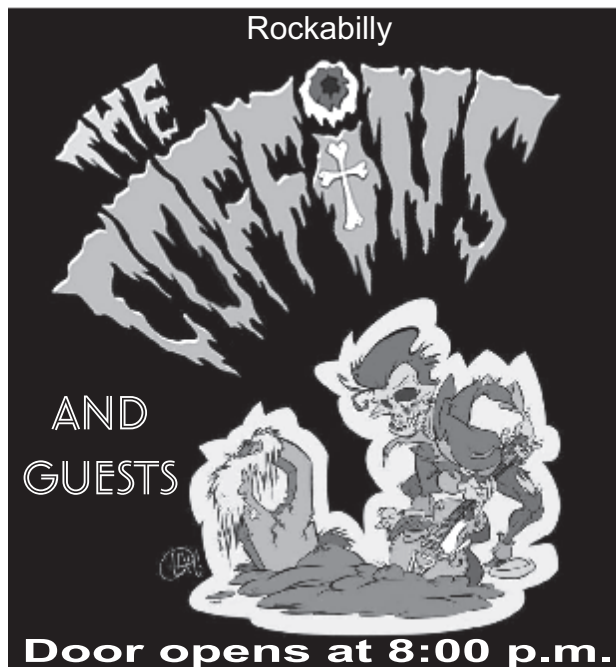

Chapleau Public Utilities Corporation**

The Ontario Energy Board has received an application on November 10, 2008 under section 78 of the Ontario Energy Board Act, 1998, S.O. 1998, c. 15 (Schedule B), seeking approval for changes to the rates that Chapleau Public Utilities Corporation ("Chapleau") charges for electricity distribution, to be effective May 1, 2009. The Board has assigned the application file number EB-2008-0165. The Board's decision on this application may have an effect on all of Chapleau's customers. The application was filed under the Board's guidelines for 3rd Generation Incentive Regulation, which provides for a mechanistic and formulaic adjustment to rates between cost of service applications.

Any change to the rates that Chapleau charges for electricity distribution will be reflected in the delivery charges. Delivery charges are one of four regular items on residential and general service customers' electricity bills and vary depending on the amount of electricity consumed.

Chapleau indicates that if the application is approved as filed, a residential customer consuming 1,000 kWh per month would experience an approximate 1.4% increase in their delivery charges. This is a \$0.50 increase per month on their bill. A small general service customer consuming 2,000 kWh per month and having a monthly demand of 50 kW or lower would experience an approximate 2.8% increase in their delivery charges. This is a \$1.74 increase per month on their bill.

How to see Chapleau's Application

Copies of the application are available for inspection at the Board's office in Toronto and on its website, www.oeb.gov.on.ca, and at Chapleau's office and may be on its website.

How to Participate in the Rate Proceeding

The Board intends to proceed with Chapleau's rate change application by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any objections to a written hearing must be received by the Board and copied to the applicant at the addresses below no later than **December 17, 2008**. The Board will not be awarding costs in this matter.

Anyone who wishes information and material from the applicant that is in addition to the evidence filed with the Board and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the applicant on or before **January 5, 2009**. The applicant shall file with the Board complete responses to the interrogatories and deliver them to all parties who asked interrogatories no later than **January 19, 2009**.

Anyone who wishes to make a submission on the application must file that written submission with the Board and deliver it to the applicant by **February 2, 2009**. If the applicant wishes to respond to the submission(s), the written response must be filed with the Board and delivered to all parties who made submissions by **February 17, 2009**.
