Shocked over Children's Aid decision to withdraw services

all of the Foster Care clients will be moved over to the Timmins Agency in March 2007. As a consequence, Chapleau will lose its existing Case Officer.

The second phase of the plan is to transfer all of the current programs and services to the K u n u w a n i m a n o Children and Family Services on April 1, 2008, once the agency has received the mandate from the Ministry of Children and Social Services to operate as a full-fledged Children's Aid agency.

C h a p l e a u residents Micheline and Claude Boisvert are no strangers to the Children's Aid Society. Over the years they have highly contributed to fostering and helping area children in time of need. The couple continues to do so to this day with great enthusiasm and obvious loving care for the children.

With great sadness, Mrs. Boisvert explained, in an interview with the Chapleau Express, her concerns over the decision to close the local Chapleau Children's Aid Society office and the transfer of our local case Officer Richard Fournier.

"We will not be able to pursue the work that we have been doing without a case-worker in Chapleau and especially without Richard," stated Mrs. Boisvert. "He was so important to a lot of kids and continues to be important to this day. The kids trusted him. Trust is very important to these kids."

Mrs. Boisvert added: "Richard was always available twenty four hours a day in case of emergencies. He was called more than once during the night to attend to an emergency, whether medical or otherwise."

Reacting to the decision to close the Chapleau office Mrs. Boisvert said she feels let down by the system. "We can't solve all situations with a telephone call," she stated and added, "sometimes we need a situation dealt with immediately and if that ceases to happen in the near future we are going to be in a lot of trouble. We have to deal with children that were let down at one point or another and now I feel that it's our turn to be let down. We're not dealing with parts or numbers" she went on to say "but children, precious children, what is going to happen to the children?"

Mrs. Boisvert concluded, "unfortunately, if the situation is not rectified we will be losing some good dedicated foster parents in Chapleau. Foster parents are a special group of people and they are not that easy to find."

Officials in this community are expressing

shock over the decision by the Children's Aid Society of the Districts of Sudbury and Manitoulin to transfer all of its Foster Care

cases to Kuuwani-mano Children and Family Services which is a First Nation Agency in Timmins.

Children's Aid decision "Totally unacceptable"

Reaction to the loss of Chapleau's only childcare worker under the Children's Aid Society of the Districts of Sudbury and Manitoulin has been swift and critical.

Mayor Earle J. Freeborn says the move is totally unacceptable. "We are vehemently opposed

to this negative action that will have a severe impact on child care services in our small northern community and put children at risk unnecessarily," stated the Mayor who outlined his concerns in a letter to the Director of the Children's Aid Society of the Districts of Sudbury and Manitoulin and copies to Mary Anne

Chambers, the Minister of Children and Youth Services and Algoma-Manitoulin MPP Mike Brown.

Mayor Freeborn stated the need for immediate action at a time of emergency situations when a child is in need and in peril has always been handled in a professional manner by the child care

worker and foster parents. Equally important is the follow-up counseling provided.

"This cannot change and on behalf of the young children who will be negatively impacted by this move, we take this stand for their future welfare and well-being."

Mayor Freeborn implored the

Society's Board of Directors "to reverse this unhealthy decision as quickly as possible.

"The movement of government services from smaller communities to larger centralized areas is a backward step that has got to stop," stated the Mayor.

Victim of January home invasion dies

The elderly victim of a January home invasion robbery at a Senior's Complex on the Brunswick House First Nation territory has died in Chapleau Hospital.

On Sunday, February 11, 2007, Henry McWATCH age 78, who had been stabbed during the robbery, succumb to his injuries. A post mortem examination was performed on Tuesday, February 13, 2007.

Donald Lawrence NESHAWABIN, age 47, of no fixed address was arrested in the City of Greater Sudbury on January 10, 2007 by Greater Sudbury Police Service and charged by the OPP with Attempt Murder, Robbery and Wearing a Disguise with Intent. The charges have since been elevated with the victim's death.

Today, Wednesday, February 14, 2007, Neshawabin will be arraigned at the Chapleau Provincial Court on the charges of Second Degree Murder, Robbery and Wearing a Disguise with Intent.

At the request of the Nishnawbe-Aski Police, the investigation is being conducted by members of the OPP Chapleau Detachment and North East Region Criminal Operations, under the direction of Detective Inspector Ken LEPPERT of the OPP Criminal Investigation Branch.

Province Supports Community Development In Chapleau

McGuinty Government On The Side Of Northerners

SUDBURY - The McGuinty government is supporting community development in Chapleau by investing in a business plan for the establishment of a bio-energy processing facility, Minister of Northern Development and Mines Rick Bartolucci announced today. "We are on the side of northerners. That's why we are supporting our northern communities as they explore the development of new local industries," said Bartolucci. "Economically diverse

communities are an important part of building a prosperous northern economy."

The Northern Ontario Heritage Fund Corporation (NOHFC) is providing the Township of Chapleau with \$47,500 to complete a business plan for the possible establishment of a bio-energy processing facility. This phase of the project will include market and feasibility studies, plus an engineering analysis that will help determine the suitability of Chapleau as a location.

Construction starts on state-of-the-art OPP forensic identification unit

New Facility Will Add Significantly To The Fight Against Crime In Northern Ontario

SAULT STE. MARIE, ON, Feb. 13 /CNW/ - The Ontario Provincial Police (OPP) Forensic Identification Unit in Sault Ste. Marie is being built as part of the McGuinty government's \$50-million investment in new facilities for front-line police officers, Community Safety and Correctional Services Minister Monte Kwinter announced today.

"Our government is on the side of Ontario families concerned about crime and safety," said Kwinter. "The new forensic identification unit will significantly increase the OPP's ability to meet the demands of modern forensic investigations and keep our communities safe. It's another example of our commitment to the safety and prosperity of our northern communities."

The new state-of-the-art 12,000-square-foot building will house many of the latest forensic technologies now available to apprehend and convict offenders. The facility will be located on a government-owned site at 740 Great Northern Road, adjacent to the current OPP detachment.

"With this new facility, our government is supporting the OPP and continuing to grow Sault Ste. Marie's economy," said Oraziotti. "This investment will give law enforcement professionals access to the modern equipment they need to serve our community more effectively."

OPP forensic

identification units are responsible for crime scene management, evidence processing in support of the investigation and prosecution of crime and for the integrity and continuity of evidence from the time it is collected to the time it is presented in court.

"This is one of several projects in the McGuinty government's five-year \$30-billion plus infrastructure renewal plan to modernize facilities in the justice and law enforcement sector," said Public Infrastructure Renewal Minister David Caplan. "The Ontario Realty Corporation is

working with the OPP to deliver a facility that meets all their requirements."

"This new unit will allow officers to use the most up-to-date tools in forensic sciences," said OPP Commissioner Julian Fantino. "This plays an important role in our fight against crime throughout northern Ontario."

Plans are to have the new facility up and running by winter 2007.

The McGuinty government is contributing to the safety, health and prosperity of the province by helping our policing partners put 1,000 new police officers on the streets

and giving them the tools they need to keep Ontarians safe, expanding access to health care, strengthening public education and encouraging job creation.

The new Sault Ste. Marie facility will be approximately 12,000 square-feet and will:

- Contain state-of-the-art evidence processing rooms with a specially constructed heating, ventilation and air conditioning system to minimize health risks from harmful pathogens and chemical agents
- Incorporate evidence-processing rooms to facilitate the simultaneous exami-

nation of forensic evidence from single or multiple crime scenes

- Ensure that the examination of forensic evidence from crime scenes meets strict judicial standards for integrity and impartiality.

Chapleau Innovation Centre Coordinator

Nishnawbe Aski Nation supports Wahgoshig's demand for recognition of First Nation child and family service

CNW-Nishnawbe Aski Nation (NAN) Grand Chief Stan Beardy says given the inherent right to self-governance, First Nation child and family service agencies, specifically Timmins based Kunuwanimano, should be recognized as the primary service for First Nations rather than the Government of Ontario's Children's Aid Society (CAS).

"The most recent practice of CAS brings back many memories of the 'Sixties Scoop'

not only for those directly involved, but for the community of Wahgoshig and the First Nations of NAN as a whole," said NAN Grand Chief Stan Beardy. "Without proper recognition of First Nation child and family service agencies as the ideal and primary service, First Nations across Ontario will continue to feel victimized as a result of history seeming to repeat itself."

After a public retrieval of an infant by

two workers from Timmins and District Children's Aid Society and City Police at a Timmins shopping centre last week, Wahgoshig First Nation (one of NAN's 49 First Nation communities) declared Friday the community is restricting CAS and Ministry of Youth Services from entering the community.

"We are losing our children to a system that does not belong to us," said Wahgoshig First

Nation Chief Dave Babin adding this is an issue that must be addressed throughout the North. "Ideally all First Nations should be governed by a First Nation Child and Family Service not a government CAS. If it is a case of a First Nation then it should be handled by a First Nation organization."

Kunuwanimano is a First Nation Child and Family Service Agency serving 11 of NAN's 49 First Nation

communities. It operates out of Timmins, Ontario.

The "Sixties Scoop" refers to a period between the 1960s and 1980s where a documented 17,000 First Nation children were taken from their homes to be adopted by non-native families across Canada, United States of America, and Europe. Wahgoshig Chief Babin considers this period an attempt at genocide and is seeking reparation

under the Genocide Convention Act (1949), including establishing a national inquiry to investigate policy and period purpose.

Babin says one of his community's objectives is to negotiate with the Ministry of Youth Services, however Wahgoshig First Nation will be closed to them and CAS until Kunuwanimano is designated and CAS adheres to its workplan.

Chapleau Public Utilities Corporation a présenté une requête à la Commission de l'énergie de l'Ontario afin de modifier ses tarifs de distribution. La requête a été déposée conformément aux lignes directrices fixées dans le « Report of the Board on Cost of Capital and 2nd Generation Incentive Regulation for Ontario's Electricity Distributors » publié le 20 décembre 2006, que vous pouvez obtenir auprès de la Commission de la manière décrite dans la section « Vous voulez en savoir plus? ».

La facture d'électricité normalisée des consommateurs résidentiels et des petits consommateurs du service général comporte quatre lignes : Frais d'électricité, Frais de livraison, Frais réglementés et Redevance de liquidation de la dette. La requête en modifications tarifaires concerne uniquement la ligne Frais de livraison de la facture. Si elle est approuvée, le consommateur résidentiel typique qui utilise 1 000 kWh par mois constatera une diminution d'environ 0,1 % sur sa facture d'électricité. Le petit consommateur du service général qui utilise 2 000 kWh par mois et dont la demande mensuelle est égale ou inférieure à 50 kW constatera une diminution d'environ 0,1 % sur sa facture d'électricité.

Chapleau Public Utilities Corporation peut déposer une requête pour un rajustement tarifaire concernant spécifiquement les compteurs intelligents. 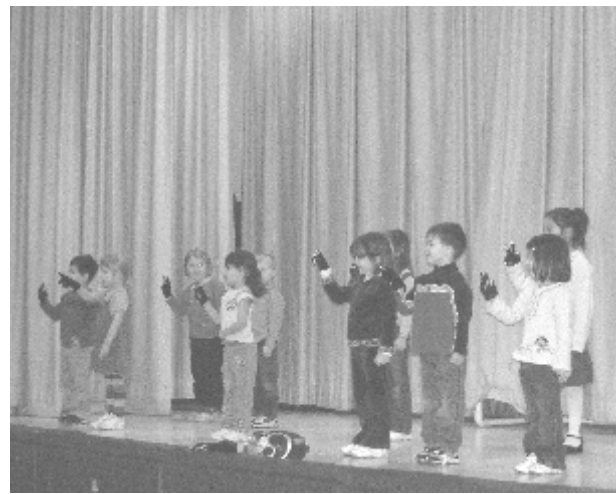

NOTICE OF APPLICATION AND WRITTEN HEARING FOR AN ELECTRICITY DISTRIBUTION RATE CHANGE AND NOTICE OF COMBINED PROCEEDING AND HEARING RELATING TO SMART METERS

Chapleau Public Utilities Corporation

Chapleau Public Utilities Corporation has filed an application with the Ontario Energy Board (the "Board"), received on January 25, 2007 under section 78 of the Ontario Energy Board Act, 1998, S.O. 1998, c.15 (Schedule B). The Board has assigned the application File No. EB-2007-0515. This Notice contains important information about participation in the hearing associated with the applicant's rate change application ("rate proceeding") and about participation in a combined proceeding relating to rate adjustments for smart meters ("smart meter combined proceeding").

Chapleau Public Utilities Corporation has applied to the Board to change its distribution rates. The application has been filed on the basis of the guidelines set out in the December 20, 2006 "Report of the Board on Cost of Capital and 2nd Generation Incentive Regulation for Ontario's Electricity Distributors", available from the Board as described under "Need More Information?" below.

The standard electricity bill for residential and small general service customers has four line items: Electricity; Delivery, Regulatory and Debt Retirement Charge. The rate change application affects only the Delivery line of that bill. If approved, a typical residential customer consuming 1,000 kWh per month would experience an approximate decrease of 0.1% in the electricity bill. A small general service customer consuming 2,000 kWh per month and having a monthly demand of 50 kW or lower would experience an approximate decrease of 0.1%.

Chapleau Public Utilities Corporation may apply for a specific rate adjustment related to smart meters. This adjustment is referred to as a "smart meter adder", and represents temporary advance funding to facilitate the acquisition and installation of smart meters through the 2007 rate year. If a smart meter adder is applied for, the percentage decrease in the electricity bill referred to above do not include the amount of Chapleau Public Utilities Corporation's smart meter adder. The prudence of the amount requested by Chapleau Public Utilities Corporation for its smart meter adder will not be examined as part of the rates proceeding. It will be dealt with in a separate process at a later date.

As a starting point to that future process, certain general principles will be the subject of a combined proceeding for which a hearing will be held after May 1, 2007. The combined proceeding will involve a number of electricity distributors, and may include or consider Chapleau Public Utilities Corporation's smart meter adder. Further information about the treatment of smart meter adders and the nature and scope of the combined proceeding may be found in the January 29, 2007 "Report of the Board on 2nd Generation Incentive Regulation for Ontario's Electricity Distributors: Addendum for Smart Metering Rates", available from the Board as described under "Need More Information?" below.

How to see Chapleau Public Utilities Corporation's Pre-filed Evidence

Copies of the application are available for inspection at the Board's offices in Toronto and on its website, and at the Chapleau Public Utilities Corporation offices and on its website, if available.

How to Participate in the Rate Proceeding

The Board intends to proceed with Chapleau Public Utilities Corporation's rate change application by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any objections to a written hearing must be received by the Board and copied to the applicant at the addresses below no later than 10 days from the date of publication of this Notice or, if you have been served this Notice directly, no later than 10 days from the date of service. The Board will not award costs in this matter.

Proceeding by way of written hearing, the Board requests interested parties to file submissions, in writing, setting out their views on the application. You must forward three paper copies and, if possible, an electronic copy in Word format and in searchable PDF format of your submission to the Board and one copy to the applicant at the addresses below. All submissions must be received by the Board and the applicant at the addresses below no later than 21 days from the date of publication of this Notice or, if you have been served this Notice directly, no later than 21 days from the date of service. If Chapleau Public Utilities Corporation wishes to respond to a submission, the response must be filed with the Board and copied to the party that made the submission no later than 7 days from the date of receipt of the submission.

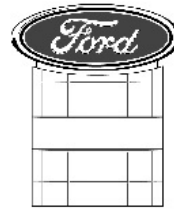

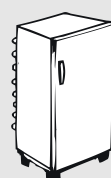

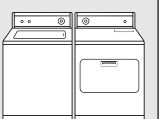
