The construction of the motel complex began in 1998. At the time, although other motels existed, none were of the stature that this one would become.



FORESTRY

The appetite for economic stimulus is growing in our country as the challenges of a prolonged recession make themselves clear. The government has indicated a willingness to help the auto industry, recognizing the importance of that industry to the national economy's well being.



The same argument can be made for the forestry sector, a crucial part of our economy that is not isolated to one region or province.

When Northern Ontario MPs and MPPs met in Thunder Bay in mid-December 2008, to discuss the challenges facing this sector, we were already aware that the economic

slowdown would have an effect on this important component of our regional economy. In the past few weeks, we have witnessed concrete examples of just how difficult the challenges will be. In our riding alone, there have been 120 layoff notices from Haavaldsrud in Hornepayne, a four week shut-down at the Tembec sawmill in Kapuskasing, and concessions sought from workers at Columbia Forest Products in Hearst, all of which have very immediate consequences on our smaller communities. To that end New Democrat MPs and MPPs from across Northern Ontario are joining with labour and community leaders to call for immediate action from the federal and provincial governments.

In our meetings with stakeholders we were able to learn that what is needed is a practical plan that will

in our forestry sector and protect workers facing layoffs. We are echoing the concerns of industry, who point out the immediate need for access to reasonable credit, by calling on the federal government to create a new loan guarantee program. A program that will make sure Ontario doesn't lose good companies and jobs to an international credit crunch. We also want to see real reform to the employment insurance system to increase benefits and expand eligibility with real help for training workers displaced by permanent job losses in the forestry sector.

sustain and create jobs

From the Ontario government, we are calling for the introduction of an industrial hydro rate to help the forestry sector become more competitive, a practice that has been effective in Manitoba where there have been no permanent shutdowns in the forestry sector.

We would also like to see the province establish a Jobs Protection Commissioner who would have the power to step in when there's a major layoff or shutdown, and work with workers, the employer, banks and community to maintain employ-ment. This is a measure that worked in BC, where, over an 11year period, between 1990 and 2001, it saved 75,000 good BC jobs.

When considering government assistance on a level similar to that being proposed for the auto industry, we have to bear in mind that the forest products sector is one of Canada's leading industries shipping over \$40 billion of goods annually. We also must remember that forestry jobs are good jobs. The average wage per employee was \$46,300 in 2005; the national average wage per employee is

\$37,900, according to a Statistics Canada survey of employ-ment, payroll and hours, and that each of these jobs creates an estimated four spin-off jobs.

It is clear that the challenges facing the forestry sector are considerable and will require a collaborative effort from industry, labour and government to create the conditions in which this sustainable industry can flourish and keep these important jobs in our communities for generations to come.





> This means that any man who has been diagnosed with prostate cancer or whose health care practitioner suspects prostate cancer will be able to get a publicly funded PSA test faster and closer to home.

The PSA test is a blood test that measures the amount of PSA in the blood. PSA is produced by the prostate and is normally present in a man's blood in small amounts. An elevated PSA level may be an indication that cancer is present and that further monitoring is required.

"In 2007, nearly 9,000 Ontarians were diagnosed with prostate cancer. I encourage all men to talk to their health care practitioner about prostate cancer and the PSA test," said Brown.

As of January 21, 2009, the Smoke-Free Ontario Act prohibits smoking or having lighted tobacco in a motor vehicle while a person under 16 years old is present. Second-hand smoke levels in motor vehicles can be up to 27 times greater than in a smoker's home. It's even a risk on short trips and when the windows are rolled down.

Children who breathe second-hand smoke are more likely to suffer health problems such as sudden infant death syndrome, asthma and, later in life, cancer and cardiac disease.



Special to the Ontario Federation of Snowmobile Clubs: No matter how you ride, snowmobiling poses certain inherent risks because it occurs in an unpredictable and uncontrollable natural setting far away from civilization and emergency assistance. That said, 99.9% of snow-mobilers return home safely after each ride. Ensure you continue to be one of them by taking the following precautions...

Bright Colours: It's important that others see you clearly, so enhance your visibility by wearing a brightly coloured snowmobile jacket with lots of reflective material. The best option is blaze orange, but reds and yellows are also good. Same goes for your helmet. Just ask your buddies what is easier to follow: black or a bright colour?

Protective Vest: If you do get into an impact situation, wearing body armour such as a TekVest under your jacket could save your life. Besides, it adds a layer of warmth and maybe a little buoyancy too. I've worn a TekVest for years and it's very comfortable. So take a tip from professional racers: never go snowmobiling without one! Check it out at tekrider.com

Studs: Trac-tion products won't make much difference in snow, but when your track suddenly encounters ice, studs can make the difference to staying in control or not. Think an unexpected slippery corner, an icy slope, glare ice on a lake, or any other scenario where the surprise of a spinning or sideslipping track threatens your well-being. Studs give you that little extra edge when you most need it.

Sled Platform: The new rider forward platforms signifi-cantly improve handling and control. By moving the centre of gravity forward and lower, more weight is over the skis and the rider can steer and manoeuvre more easily. Ski-Doo says their REV and **REV-XP** platforms make us better riders and it certainly works for me. Again, a rider forward platform gives you extra edge when it counts.

ICE (In Case of Emergency): ICE is a method of contact during emergency situations. All you need to do is store the number of a contact person or persons that should be contacted during emergency under the name 'ICE' in your cell phone. In an urgent situation, emergency services personnel and hospital staff would then be able to quickly contact the right person by simply dialling the number you have stored as 'ICE.' For more than one contact name, simply enter ICE1, ICE2 and ICE3 etc. Now we can all ride with much greater peace of mind! SPOT: SPOT is

a handheld satellite messenger system that works anywhere in Ontario to send an emergency distress signal and your GPS coordinates. With SPOT, you can also email or text message your pre-programmed contacts asking for assistance, check in to say you are okay, and track your daily progress on Google Maps[™]. Although SPOT does not receive incoming messages and is not intended to serve as an en route GPS navigator, its durability, reliability and ease of use make it a very costeffective way to increase your personal safety in the great

You'll notice that all of the precautions noted above have nothing to do with changing the way you actually ride and that's deliberate. We each choose the riding style that works for us and may not wish to change it. But we'd be fools not to take sensible precautions that reduce our risk without reducing our fun. 
