Chapleau told to ante up if it wants an increase in police services

Public meeting is planned

If this community wants more police resources stationed here, then it should also expect to pay for them.

In the wake of a string of break-ins and vandalism this year, council met last Monday with Staff Sergeant Dan Dawson, who is the Area Commander at the Superior East Detachment of the Ontario Provincial Police which includes Chapleau.

Mayor Earle Freeborn said, "We have some serious break-ins and people breaking the law here." However, Staff Sergeant Dawson said the crime rate hasn't gone up per se.

The township has called for an increase in policing to

a 24 hours per day, seven days a week level. But that would require boosting the local compliment of 12 officers to 14 and as a result add to the cost. The existing level of service costs the municipality approximately a half million dollars per year.

In the meantime, Staff Sergeant Dawson pointed out some changes, which are designed to increase the visibility and presence of officers, including more visibility in the downtown.

During the meeting, council was told even though there has been local OPP support to have Chapleau designated an administrative center for a new cluster

which would include Gogama and Foleyet, it has never materialized for reasons unknown.

"We still can't understand why Chapleau didn't get a cluster," Staff Sergeant Dawson told Council.

When asked by Mayor Freeborn what council should do now, Dawson replied: "What you're doing now. Keep the pressure on."

He earlier stated additional policing, including the posting of a Staff Sergeant would only increase the cost while there would be no improvement in policing. Dawson told Council he is only a phone call away and at the same time two senior sergeants are already in service locally.



During the meeting, Mayor Freeborn stated the efforts to have a cluster office and its own commander located in Chapleau was not a reflection on the level of service now being







provided by Staff Sergeant Dawson.

The OPP is in the process of determining the cost of fulfilling the Township's request for round the clock policing.

Chapleau residents will have an opportunity to have their say in the matter.

Mayor Earle Freeborn said Monday when the costing is determined a public meeting will be called.

Chapleau proposal accepted

Friday July 13, 2007, Chapleau ON:

The Chapleau Regional Development Corporation (CRDC) and the Township of Chapleau are pleased to announce the success of the Northeast Superior Forest Community proposal to Natural Resources Canada. This application was submitted by the CRDC on behalf of the Townships of Chapleau, Wawa,

White River, Dubreuilville, Hornepayne and Manitouwage.

This proposal was submitted in October 2006 and has been under review by Natural Resources Canada's Forest Community Secretariat until this past week. In a recent letter notifying the CRDC of its acceptance, the allocation of up to \$325,000 per year for the next five years was

announced. This \$1,625,000 in funding for this area is one of only 11 approved projects across Canada.

"This project is designed for the region to study and become specialists in the area of non-timber forest products," says Michel Sylvestre, Chair of the CRDC. "The recent downturn in the forestry sector has created a need for our region to work together to find ways

to diversify our economies and to find new industries to make use of our forests. The success of this application is a huge step forward in helping us achieve our goal."

Earle Freeborn, Mayor of Chapleau adds "On behalf of the mayors in our region, I'd like to extend our thanks to the CRDC for their hard work in bringing this project forward. Each of the communities involved in this project is eager

to work in partnership to build a strong non-timber forest products industry that will put our small communities on the map."

The Northeast Superior Forest Community project partners are currently finalizing their business plan for an April 1, 2008 start date. More information on this project will be made available over the coming months.

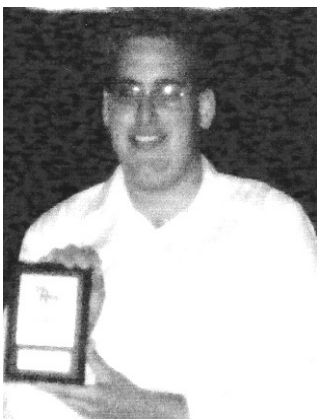

Municipality wants to be recognized

Chapleau Township wants assurance it will be recognized for the role it played in the Waterfront Development on a commemorative plaque the Rotary Club proposes

to place at the gazebo.

The Waterfront Development, considered a jewel of the community, was created by the township under the direction of a committee of local citizens. Total cost to

the municipality was approximately \$600,000 dollars.

Now, the Rotary Club, which made the waterfront pavilion a reality, wants to continue to develop the area.

In a letter to council Club Secretary, George Evans outlined the latest plans, which he described as another contribution to the "Greening of Chapleau." The plan, which is currently being developed, would include some shrubs and flowers around the pavilion and gained approval on the assurance it would be maintenance free, a request by Mayor Earle Freeborn.

The Club also said it would like to place, on one side of the steps leading into the pavilion, a boulder bearing the Rotary Wheel with a brief bilingual description commemorating the Rotary Club's involvement in making the pavilion a

reality.

While the Council appeared to support the proposal, it also wants to ensure the Township is also recognized for its role in the project and at the suggestion of deputy Mayor André Byham is asking for a proposed description

of the plaque.

Councillor Keith "Bud" Swanson requested the Township be recognized in the wording on the plaque to the effect the Rotary Club in partnership with the Township carried it out.

APPLICATION FOR AN AGGREGATE PERMIT in the geographic Township of Chapleau

NORTHERN HAUL CONTRACTING (1232291 ONTARIO INC.) of Chapleau, Ontario has made application to the Chapleau District Office of the Ministry of Natural Resources (MNR) for an aggregate permit, under the Aggregate Resources Act, R.S.O. 1990, for the purpose of operating a sand and gravel pit in part of Lot 8 and 9, Concession VI, in the geographic Township of Chapleau, in the Territorial District of Sudbury, containing 16.101 hectares, more or less. The site is located almost five kilometres southwest of the Town of Chapleau and can be accessed by the Esher-Healey Road being 0.7 kilometres south of the said road.

The application is being prepared in accordance with the Aggregate Resources of Ontario Provincial Standards for a Category 9 Site Plan for above groundwater extraction of pit operations. Northern Haul Contracting is prepared to extend the existing maintenance agreement with the MNR for use of the additional section of the Esher-Healey Road required to access the location upon commencing on site operations. The applicant is also prepared to make any repairs to the Three Mile Rapids Bridge as a result of their usage of the same.

The application is currently being screened as a Category "B" Project under the Class Environmental Assessment for MNR Resource Stewardship and Facility Development Projects in accordance with the Environmental Assessment Act, R.S.O. 1990. Comments on the proposed project are to be received by August 13th 2007. Only those persons or agencies that commented or those who requested notice will be notified directly upon completion of the project evaluation. The project may then be implemented without issuing further general notice.

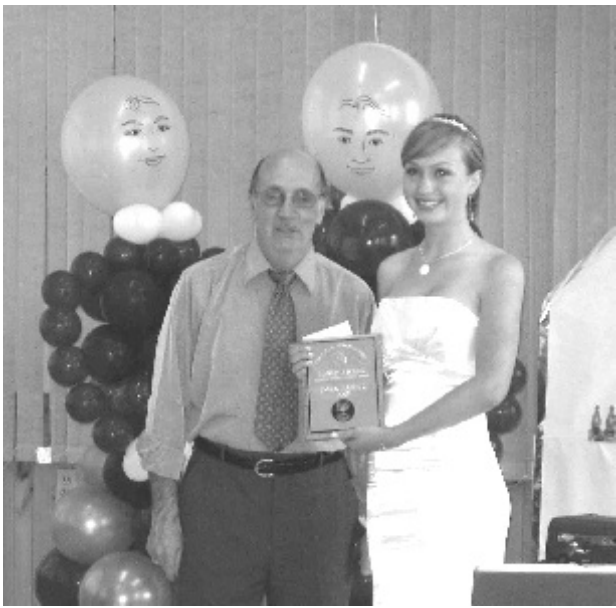

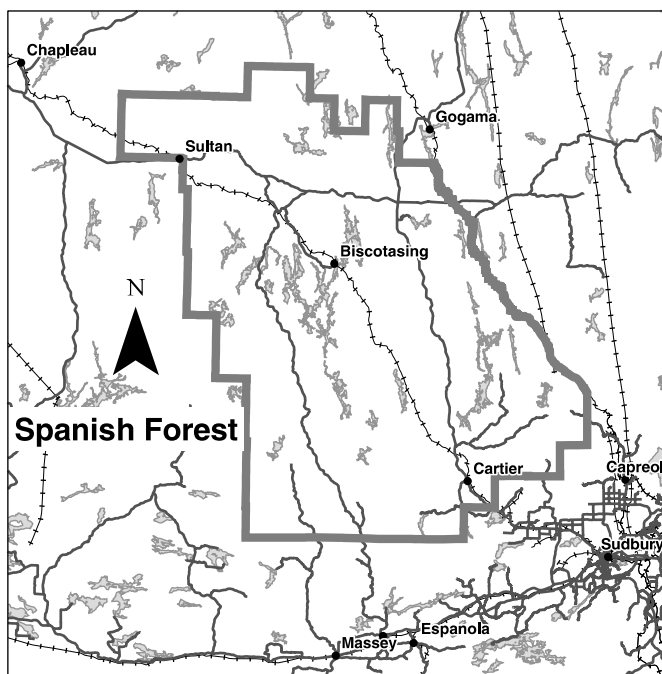

Gardening from the ground up

Kinder gardening #1: Green Time vs. Screen Time

Did you know that watching television slows your metabolism, lowers your body's melatonin production, can change how your body uses dopamine, can upset hormonal balance, raises stress levels, and reduces activity in the left half of your brain? The result of all of this is that watching t.v. (or movies, or video games) leaves you feeling lethargic but restless, more prone to negative feelings, less able to think rationally or control impulsive

reactions, and less able to pay attention. These effects can last for hours after you've switched off the t.v. set, and can contribute to long term conditions. The effects are even more pronounced in children, and there is growing evidence that they can have a permanent impact on the mental, physical, and emotional development of young children. Scary, isn't it?

The good news is that contact with nature has been proven to counteract those effects. Being in natural surroundings lowers stress levels, and actually causes a measurable change in brain function, promoting a calm, focussed state of mind and allowing the body to rebalance itself. Some researchers call

this "the potting shed effect", and it works for everyone, not just kids! Just being out of doors surrounded by plants is good for kids, but gardening specifically has been proven to greatly improve children's self-confidence, which has wide ranging effects on learning and social interactions, and gardening has also been shown to reduce hyperactivity and symptoms of attention disorders. Many countries use "outdoor

classrooms" or gardening projects so that all schoolchildren can enjoy the benefits that nature has to offer.

If that isn't enough to convince you that gardening is great for kids, here are some more reasons: Gardening puts kids in touch with natural life cycles and ecology, in effect giving them hands-on science lessons. It teaches patience in waiting to see the results of their work (delayed gratification), and builds an understanding of time as they watch plants

grow and change with the days and seasons. Learning to handle plants gently builds fine motor skills, while digging, pulling, raking, and carrying offer a constructive outlet for a need to move. The act of caring for plants teaches responsibility and builds a caring attitude, and has been found to help children deal with grief or trauma. Gardening also stimulates and refines the senses, and teaches children to become more observant. It builds an appreciation for

beauty, diversity, and the interdependence of life. Best of all, it is both fun and rewarding, and friends and family members of any age can enjoy it together.

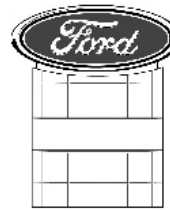

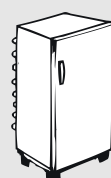
