Questionable action by Council denies volunteer appointment on CDC Board

Jocelyne Bernier, RBC Bank Manager in Chapleau is baffled.

She has been refused an appointment to the Chapleau Development Corporation

Board by Town Council. With such a high demand for volunteers to sit on different boards and committees, this decision of inaction by Council is an embarrassment to this community. The Township of Chapleau has gone as far as to advertise in the newspapers to seek volunteers to sit on various boards and committees.

In the June 25th Council meeting in which Terry Black, Roger Perreault and Kevin Lindquist were appointed to the board, the vote to nominate Mrs. Bernier in Resolution 19-269 was defeated. The motion

was brought forth by councillor Lacroix but was not seconded by either councillor Bertrand or councillor Greig. Councillor Crichton-Bernier was absent without excuse.

As there was no apparent reason for the Council refusing her nomination to the board a letter was written to Council by Mrs. Bernier requesting an explanation.

When the BR&E report was published last fall, it was obvious that issues with certain members of both Council and administration had to be rectified. It is apparent that some individuals did not get

the message.

Certain councillors are acting as retardants in the advancement and well being of our community. Tax payers should receive a public explanation from these councillors as to the reasoning behind their substandard decision making and lack of interest. They have to be held accountable for derailing progress and now preventing quality volunteers to serve on committees and boards. They represent each and every voter in the Township of Chapleau and as councillors, they have to act accordingly.

Why have

successful committees and their chairs been targeted by certain individuals? Are successful committees raising the bar a little too high?

The best interest of the community should be at the forefront. This has not been the case.

If we, as a community, promote volunteerism, we must follow up and support the people that come forward to serve their communities. As an individual, it's hard enough to make the decision to get involved but to be humiliated in the process is totally unacceptable.

The Terrace Bay Mill in Northwestern Ontario is returning to operation, supporting more than 1,900 jobs across the province

Aditya Birla Group has agreed to purchase the assets of the idled mill, subject to court

approval, and plans to invest more than \$250 million to convert the facility to dissolve wood pulp for rayon fibre.

LETTERS TO THE EDITOR

Dear Editor,

This letter is in response to the article written by Mario G. Lafreniere regarding fundraising and the Canadian Cancer Society. Unfortunately, Mr. Lafreniere based his information on a misleading report that circulated over a

year ago. We would like to set the record straight on a few points.

The Canadian Cancer Society, through the generosity of volunteers and donors like those of Chapleau, fights cancer on a number of levels. Cancer is

complex and while cancer research remains one the most important areas that we fund, it is not the only area where we invest in the fight against cancer. We are the largest charitable funder of cancer research in Canada and contributed \$46 M to cancer research in 2011-12, including the funding of 7 clinical trials that were offered to patients in Sudbury and the surrounding areas. We are physically in communities across the province, supporting cancer patients and their families, responding to questions about cancer, offering peer support and driving patients to their cancer appointments. Through the Sudbury office, which serves Chapleau residents, 37 volunteer drivers drove 309,257 km assisting 1288 adults and children with 8625 trips to and from their treatment at a cost of \$206,000. We continue to advocate at all levels of government to improve the

lives of Ontarians, cancer patients and caregivers. In June 2011, the Society secured a federal government commitment for a caregiver tax credit that would support those who care for loved ones suffering from cancer. We are also fighting to ban all flavoured cigarrillos, restrict teens from accessing tanning beds and fighting for better access to cancer drugs.

We know fundraising costs have risen over the past decade, but we are committed to raising the most amount of money so we can have the greatest impact. In 2011-12, the Society raised \$199 M nationwide of which \$126 M was invested in our mission delivery activities. Our fundraising costs were 32% of the total, which is in line with other organizations our size and well within the Canada Revenue Agency guidelines for charities. In addition to the fundraising the Society does, we also

Chapleau Moments

A whole varied fleet of big yellow monsters was crawling all over the place at the Chapleau Municipal (now Eugene Bernier) Airport when Margaret 'Maggie' Costello paid it a visit in the Spring of 1973.

Writing in the Sault Star, Maggie noted that Gene Bernier and Yvon Martel were "happy men" to see construction on the airstrip begin as it had been a long road since the airport idea had first been suggested and they had worked "untiringly with senior governments and others" to provide Chapleau with an airport.

Although Chapleau had an airport by 1970, the construction taking place in 1973 was in

preparation for the introduction of NorOntair service daily to the community.

Maggie's big yellow monsters were flattening out the terrain preparatory to giving it a 12-inch topping of crushed rock. In the planning stages was a terminal building too.

Upon completion, Maggie predicted that the runway as well as NorOntair service would be a "boon and a blessing in more ways than one" for Chapleau.

By the Fall of 1973, the new airstrip and a new access road to the airport had been completed.

A celebration of sorts was held when a DC-3 Dakota with Steve Herniak of Austin Airways as the

pilot came from Timmins, "floated down from the clear blue sky onto the hard and solid crushed rock runway for a short visit." It was the largest aircraft to land thus far on the new runway.

The flight had been arranged by Bill Cram, the pilot for the Ministry of Natural Resources. Included in the welcoming committee were Gene, Yvon, Walter Broomhead, Jack Russell, William Ward and others. Pilot Herniak treated a number of citizens to a flight around the area.

The next step was to bring NorOntair service to Chapleau.

Application had been made by the Fall of 1973 for an airport license and to Ontario Hydro for construction of a power line.

By early 1974, the township council and airport commission had held a meeting to review developments at the airport and plan for the introduction of NorOntair service in July.

Gene told council that a permanent terminal building would not be required at the time that the license was granted as long as one was forthcoming soon. It was completed in 1975.

The capital expenditures for the entire airport project,

from the time Gene, Yvon and others undertook it in 1963, was paid for by federal and provincial government grants and volunteer labour and equipment. In 1972, the municipality entered into an agreement with the federal Minister of Transport, and the township would be responsible only for maintenance at the airport. It was a prime example of volunteerism for the betterment of the community at its best, and involved a commitment to the project daily for more than 10 years.

On March 14, 1974, the first NorOntair flight, not scheduled, brought dignitaries to Chapleau for a day of meetings with the council and airport commission to make sure that all improvements required had been met prior to the introduction of daily NorOntair service.

"For Gene Bernier... Yvon Martel, Stan Deluce (White River Air Service) and many more who have been involved, it brought a dream to nearly final realization.," Maggie wrote.

By the summer of 1974, Chapleau had daily NorOntair service which continued until 1996 when the government of Premier Mike Harris closed it down.

In 1975, Premier Bill Davis

visited Chapleau, landing at the airport on the very day he had called a provincial election. He was visiting to visit the Chapleau General Hospital site and discuss municipal projects. In 1978, Gene and Yvon were on hand to welcome Ontario Lt. Gov. Pauline McGibbon when she arrived to officially open the Chapleau Civic Centre on June 28.

Two Chapleau men have been fined a total of \$5,300 for illegal moose hunting

Luc Bergeron and Alain Bergeron pleaded guilty and were each fined \$700 for unlawfully hunting a cow moose, \$750 for unlawful discharge of a firearm in traveled portion of roadway, \$1,000 for allowing a moose to spoil and \$200 for making a false statement to conservation officers. Luc Bergeron also received a one-year moose licence hunting

suspension; Alain Bergeron received a two-year hunting licence suspension, along with permanent forfeiture of his firearm.

Court heard that on October 11, 2010, conservation officers received a call about a rotting moose along Highway 101 in The Shoals Provincial Park. Conservation officers with a canine unit located a calf

moose that had been shot and left to spoil, along with evidence that a second moose had been killed and taken. On October 29, 2010, conservation officers searched the residences of Alain Bergeron and Luc Bergeron and seized hunting rifles and a large quantity of butchered moose meat.

The investigation revealed that on October 10, 2010, the men stopped their

vehicle on Highway 101 and shot a cow and calf moose while the animals were in the eastbound lane. Alain Bergeron shot the cow moose in Wildlife Management Unit (WMU) 35 as it crossed the highway; however, he only possessed a tag valid for WMU 32. Luc Bergeron shot the calf as it crossed the highway. The calf later died in the non-hunting-permitted side of

Shoals Provincial Park in WMU 35. The two men then dragged the cow moose across the highway into WMU 32, where it was gutted and harvested. The calf was left to spoil.

During statements both men denied shooting their firearms from the highway. Alain Bergeron later admitted that he shot the cow moose from inside of his vehicle.

Justice of the

Peace Jean-Marie Blier heard the case in the Ontario Court of Justice, Chapleau, on June 6, 2012.

How to survive mosquito season

(NC)—With the hot, humid, and dry summer months ahead, we can finally look forward to being outdoors and enjoying all the fun activities summer has to offer. However, summer is also a time where mosquitoes and deer ticks like to roam and make our lives miserable and uncomfort-

able.

Here are some tips and recommendations to make sure you make it through mosquito season:

- Wear light-coloured, loose clothes and avoid scented products when outdoors, especially from dusk to dawn, which is the peak feeding time for mosquitoes.

- Remove areas of standing water near your house as they can be breeding areas for mosquitoes.

- Clean Gutters: Gutters clogged with debris allow stagnant water to form perfect landing zones for mosquito eggs.

- Wear closed shoes and a hat to avoid ticks. Tuck pants into socks.

- Inspect your clothing and body after exploring wooded or grassy areas.

The best way to reduce bites is to use an insect repellent when spending time outdoors in mosquito-infested areas. Unfortunately not everyone takes these precautions. According to a survey conducted by

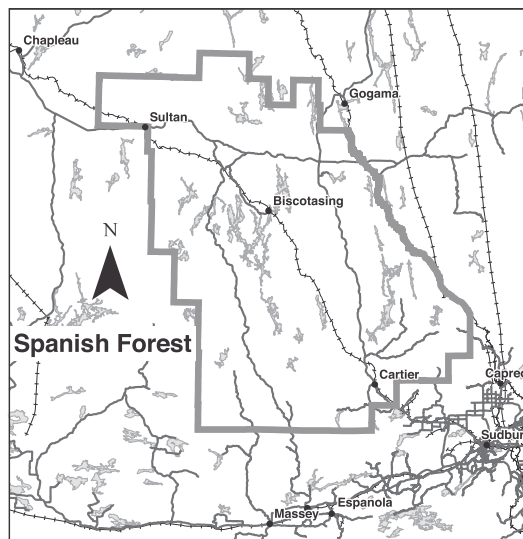

Elliot Lake shows us what it means to be Canadian

It is difficult to put thoughts together about Canada Day as Elliot Lake reels from the collapsed roof at the Algo Mall. While emergency crews worked, the country waited with baited breath and Canada Day was about the furthest thing from anyone's mind. Still, throughout the north and across the country there will be celebrations. At the very least we can say that amidst the tragedy of the past week, much of what is good about Canada has shone through.

At the centre of it all, the community has come together in grief and the spotlight has shone on Elliot Lake

showcasing a tight-knit and caring place. As news teams told the story of the emergency they also told the story of the city. More Canadians learned about Elliot Lake in the last week than anyone would have ever guessed. Across the country, people came forward to tell of their connection to the town, to send their best wishes, and share their prayers with fellow Canadians in their time of need.

It speaks to the caring nature of Canadians. The messages of support were greatly appreciated as was the way that people in the community took care of each other during the crisis. Businesses

Help Prevent Turtle Road Mortality

Ontario's turtles are struck and killed by motor vehicles every year. Some turtle populations are already under stress due to wetland loss and habitat degradation. Road mortality can be significant and contribute to putting some turtle species at risk.

During the spring and summer, the threat of vehicles to turtles is at its highest. This is especially true for females as they wander away from water in search of nesting sites. Some even try to nest on gravel roads or on the shoulders of paved roads.

What Can Drivers Do?

Watch the road carefully when you're driving, especially where the roads are close to wetlands and rivers.

Remember that turtles don't move very quickly, and their first response to danger is to pull into their shells.

If it's safe to do so, you can help by moving a turtle off the road in the direction it was heading. If the direction is unclear, choose the side with the better habitat (e.g. wetland).

Most turtles can be easily handled, but if in doubt, a shovel or stick may be gently used to encourage the turtle off the road. Moving snapping turtles by hand is not recommended, as they may attempt to bite in defence.

About Ontario's Native Turtles

There are eight species of turtles in Ontario, seven of which are considered species at risk under the province's Endangered Species Act – Blanding's Turtle, Eastern Musk Turtle, Northern Map Turtle, Spiny Softshell, Snapping Turtle, Spotted Turtle and Wood Turtle.

Turtles live a long time – some can live 90 years or longer!

Some turtles don't start to lay eggs until they are at least 20 years old, and only a small number of eggs survive until adulthood.

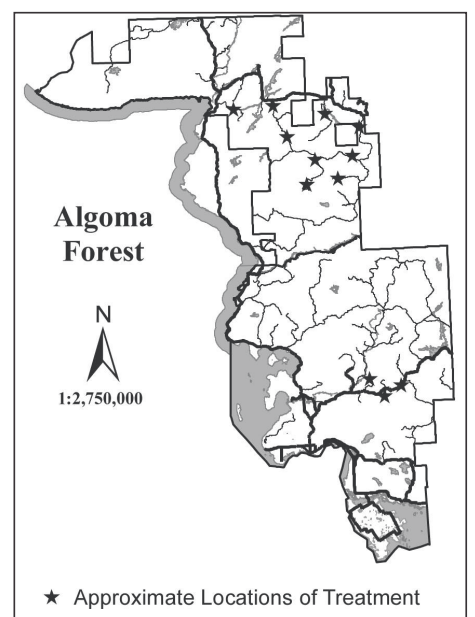

It is in our own best interest to support our local economy

One of the claims of those who support free-trade is that 'we can compete.' This is often said in a way that seems to question the patriotism of those who raise concerns about the effect of unfettered free-trade agreements. After decades spent pushing Canada in this direction we are facing the consequences: massive Canadian job losses, severely reduced retirement security, and relaxed environmental protection.

In the north we have seen a consistent drop in our traditional employers, none more than the forestry sector. As the dollar soars, the jobs dry up. Worse, in stark contradiction to the stated aims of globally competitive economies, the forestry sector in the United States remains one of the more subsidized

and protected sectors in our North American Trading zone.

The one way we can protect ourselves in this scenario is to go out of our way to buy local. Whether it is produce, products, goods or services, there is nothing binding in our trade agreements to stop an individual from making a concentrated effort to support his or her local economy. We still get fairly local dairy products. We don't have to only go to big box stores, in many communities there are still butchers and smaller grocery stores. There is no doubt that it is difficult, or perhaps even impossible, to only spend your money locally, but that shouldn't prevent people from giving it a go.

It is generally easier to buy local in the summer. Road-side stalls and farmer's markets make the very

fresh produce available in a more convenient way. But we shouldn't be just focusing on food with this mindset. There are ways people can spend their recreation time locally. I enjoy visiting communities throughout Algoma-Manitoulin-Kapuskasing in this season because there are so many festivals and special events going on. Whether it is a music festival, a pow wow, or a community fair, I leave the event more invigorated and community-minded.

I find it helpful to remember as I go out of my way to support local businesses and community efforts that it is my neighbour who I am supporting. In helping our neighbours and contributing to the livelihood of our communities we make ourselves better citizens and a little bit richer in more ways than one.

1,500 Anglers Checked During Enforcement Blitz

The Ministry of Natural Resources laid 111 charges and issued 75 warnings during a two-week enforcement blitz in northeastern Ontario. While conservation officers focused much of their effort on public safety due to the extreme fire conditions in northeastern Ontario, officers did check 1,500 anglers and other resource users from May 19 to June 1 to ensure compliance with the Fish and Wildlife Conservation Act and the Ontario Fishing Regulations. The blitz

coincided with the general opening of walleye season in northeastern Ontario. Charges were issued for:

- having an over-limit of walleye
- fishing in a sanctuary
- unlawful transportation and packaging of caught fish.

A total of 31 walleye and other illegally harvested fish were seized.

Charges and warnings were also laid under the Forest Fire Prevention Act, Small Vessels Act and Liquor Licence Act.

Several of the violations were related to non-compliance with the Restricted Fire Zone that was in place in northeastern Ontario at the time of the blitz.
