Economic benefits for our community not a priority for certain councillors

n two separate occasions in the last month, council has voted against economically profitable events, thereby tightening our economic tailspin.

The first event in question was a Bantam Hockey Tournament. What would have been a much needed boost to our local economy was cancelled because our council voted against postponing the removal of the ice from the A.W. Moore Arena by one week; that's right, one single week. It is difficult to comprehend our

council's lack of \$10.00, meals alone foresight.

Let's do some math. Theoretically, a five team tournament (not counting the host team) would bring in around 100 players and coaching staff along with approximately 176 family members. That represents nearly 70 rooms for two nights (or a total of 140 rooms). At \$69.00 a room, that adds up to around \$9600.00.

How about meals? The number of meals served over the weekend would be about 1656. Averaging the meal cost at

quickly add up to around \$19,872.00.

What about fuel? Just as our young athletes need energy, so too do our vehicles. Considering the higher traffic associated with a hockey tournament, we could have expected an additional \$7000.00 to have been spent at the local gas stations.

To summarize, the approximate financial loss incurred by our town due to the cancellation of this event sits at a grand total of \$36,535.

The alternative solution was to hold the tournament in conjunction with a midget tournament which was to be held at the end of March. The logistics involved would have made it unfeasible.

The second event in question was the Drag Race competition that was to be held by the Chapleau Arctic Watershed Snowmobile Club during the Taste of the North 2010 carnival. The Snowmobile Club was denied the annual \$1000.00 donated needed to cover insurance costs along with paramedic

In the past, this popular event attracted well over 100 participants from all over Northern Ontario. Due to a lack of familiarity, the economic loss for this event is difficult to estimate. However, it remains a loss nonetheless.

Beyond the financial losses of these two events, our community lost something much more important: an opportunity to strengthen our image as the "Friendliest Town in the North". In fact, we may have tarnished that reputation.

As representa-

tives of taxpayers, council members must serve the community, and realize that there is no room for their personal agendas. Chapleauites will not let conflicts of interest, nepotism and bad decisions go unnoticed.

As with any Township, ours will continue to be faced with many important issues requiring strong, decisive leadership, and we should accept nothing

Remember, the power to better our community's future is in their hands.

edition of this newspaper, the law states that elected officials are not responsible to judge the actions of another elected official. Truly, our hands are tied.

Many condemn me and Council for not questioning or stopping our fellow member from making the mistake. Again the law clearly states that the mayor and council do not have such a role or obligation.

Whereas the court of public opinion will condemn

immediately, the law demands each person receive their day in court. Conflict of interest law states that a person's actions must be judged by an appointed arbitrator or a court of justice.

What recourse does the public have under the legislature? Two avenues for action exist. One is for a ratepayer to lodge a complaint with the town's integrity commissioner. He/she then determines if a conflict of interest occurred based on legal stan-

dards and the code of conduct up to the discretion of each individual council.

Unfortunately, previous Chapleau councils chose not to have either. What could have been a simple process to correct this situation is not available to Chapleau's ratepayers. I must admit that I. for one, was blindsided by this. As a result, I intend to recommend that council develop a code of conduct and assign an integrity commissioner within six months. This is an embarrassment and must be corrected.

The second avenue for action is again up to the ratepayer. A ratepayer or group of ratepayers may charge the councilor in question with the conflict of interest. A court case follows. The downside is that the ratepayer(s) must pay for the lawyer's fees and court costs. To me, this makes no sense, but it is the law.

All this said, my hope is that the town will not divide over this issue. Everyone is entitled to express his or her opinion whether informed or not. But in the end, this debate must not overshadow council's efforts to improve the community and to prepare Chapleau for the future.

When Alfred 'Alf' Comte retired in 1961, he was not just remembered for his barber shop on Chapleau's main street, but also for the music that was very much a part of his life.

Arriving in Chapleau in 1911, at the age of 17 from Thouars, France, Mr. Comte became the Chapleau boys' best friend from childhood up, first working in Richard Brownlee's barber shop, then taking it over from him. He decided to stay: "It was young, it was colourful, it was growing," he said of Chapleau.

"Over the

years he made a host of friends," Margaret Costello wrote in her Sudbury Star column, marking Mr. Comte's retirement. "Among the very young, when he first clipped hair from the heads of tiny tots, and turned them in real boys, and from there on men of all ages."

However, music was very much "part of the scheme of things" Mrs. Costello wrote, "and he played the violin well, so well in fact, that he taught others" as well as playing in a popular local orchestra.

Mr. Comte recalled that in those early days the only traffic marks along main street were wagon wheel ruts. Over the years, looking out the big picture window of the barber shop he saw

At the head table with Mr. Comte were some of his old friends including Mr. Payette, George O'Hearn, Hiram Paul, Ben Vezina, J.N. Burns, James Encil, Thomas McKee, John Reid, Chapleau Reeve D.J. 'Jim' Broomhead who also played a mean sax in the orchestra, and sons Raoul and Gerard Comte, and his grandson Lawrence.

At this point, I extend my thanks to Lawrence, who we called by the nickname 'Ton' for providing me with information on his grandfather. I decided to reach out to some others to share their memories of Mr. Comte, and here are some of the replies I received. Thanks to all.

Harry "Butch" **Pellow**

"I recall many instances when I was directed to the barber in anticipation of such things as special school events, choir and church proceedings and other such activities requiring neatness of and presentation of countenance. As I recall I would often arrive in the barber shop after school ... maybe way after school... sweaty and in my woolen breeches covered in snow and damp- (and smelly

too) and told to sit on the ice cream parlour chairs against the wall to await my turn in the chair. I recall waiting sometimes for a very long time while more recent arrives in the shop (adults) would precede me.

"Only later did I appreciate that the snow covered clothes, sweaty and smelly breeches and a restless young boy were the last thing wanted before the shop closed for the evening. I and you will recall the big picture window, the dark snow covered streets and that the barber shop was the last place you would want to be when you could otherwise be playing hockey on Aberdeen Street.

"Do you recall the glass case against the inside wall of the shop, the mirrored back wall, the linoleum floor covering water soaked and spotted by the snow

that was tracked in, the wire backed, ice cream parlour cane seating, the picture of the dogs playing poker, and the long calendar with a rural scene of somewhere none of us had ever been?

"Do you recall the aroma of the after shave and the smelly stuff they sprinkled on your hair; and do you recall that you always preferred Mr. Comte to do your hair after he set you up on the board he suspended between the arms of his chair and mostly because he would put you at ease with his quiet, personal conversation, and very personal and friendly questions about yourself and your family.

"Sweet memories for me for sure. And he never forgot my name."



Public Inspection of Annual Work Schedule

The Sudbury District Office of the **Ontario Ministry of Natural Resources (MNR)** has reviewed and approved **EACOM Timber Corporation's** 2011–2012 **Annual Work Schedule (AWS)** for the Spanish Forest. The AWS will be available for public inspection at the MNR Espanola, Chapleau and Gogama Offices, the EACOM Timber Corporation, Nairn and Timmins Offices and the MNR public website at **ontario.ca/forestplans** beginning March 16, 2011.

Scheduled Forest Management Operations

The AWS describes forest management activities such as road construction and decommissioning, harvesting, site preparation; pre-commercial thinning, tree planting and tending scheduled to occur on the Spanish Forest between April 1, 2011 and March 31, 2012.

MNR has received the AWS to ensure that activities are consistent with the approved Forest Management Plan.

The following are some of the operations that are scheduled on the Spanish Forest:

- 3.5 million trees will be planted
- 3.5 million trees will be planted3,000 hectares of aerial spray
- site preparation will occur on 3,000 hectares of harvest area

Roads on the Spanish Forest may receive maintenance, which may include grading and ditching. Water crossings may be removed as part of the approved Plan.



Retirement Contribution Limits Largely Unchanged

You'll probably hate me for bringing this up, but it's time to begin planning for your 2011 taxes – or at least, about the tax implications of your retirement account contributions.

For the second year in a row, one widely used inflation measurement, the Department of Labor's Consumer Price Index for Urban Consumers (CPI-U), remained flat for the quarter ending September 30, 2010, compared to the same period a year earlier. That's important because the IRS uses this measurement to determine whether dozens of tax-related numbers will stay the same or increase from year to year.

Bottom line: In 2011, most contribution levels remain unchanged. Here's an overview of common retirement savings

Defined contribution plans. The maximum annual contribution to 401(k), 403(b), 457(b) and federal Thrift Savings plans remains unchanged at \$16,500 (plus an additional \$5,500 if you're at least 50). Other factors to remember:

Your plan may limit the percentage of pay you can contribute so, depending on your salary, your maximum contribution may

actually be less.

- Companymatching contributions don't count toward your maximum contribution.
- With pretax contributions, your account grows tax-free until withdrawn, at which point withdrawals are taxed at the rate then in effect.
- With after-tax contributions, you pay income tax on the money now, but your contributions and their earnings will not be taxed at retirement.

Individual Retirement Accounts (IRAs). The maximum annual contribution to IRAs remains unchanged at \$5,000 (plus another \$1,000 if 50 or older). Contributions to a regular IRA are not impacted by your income, but if your modified adjusted gross income (AGI) exceeds certain limits, the maximum contribution to Roth IRAs gradually phases out:

For singles /heads of households the phase-out range is \$107,000 to \$122,000 in AGI (up from \$105,000 to \$120,000 in 2010).

For married couples filing jointly, it's \$169,000 to \$179,000 (up from \$167,000 to \$177,000).

A few rules on deducting IRA contributions on your tax return:

If you're single,

a head of household or married and neither spouse is covered by an employer-provided retirement plan, you can deduct the full IRA contribution, regardless of income.

If you are covered by an employer plan and are single/head of household, the tax deduction phases out for AGI between \$56,000 and \$66,000 (unchanged from 2010); if married and filing jointly, it's \$90,000 to \$110,000 (up from \$89,000 to \$109,000 in 2010).

If you're married and aren't employer plan but your spouse is, the IRA deduction is phased out if your combined AGI is between \$160,000 (s/b)\$169,000) and \$179,000 (up from \$167,000 to \$177,000).

A final note: As an incentive for lowand moderate-income workers to save for retirement through an IRA or companysponsored plan, many are eligible for a savers

covered by an credit of up to \$1.000 (\$2,000 if filing jointly). This credit lowers your tax bill, dollar for dollar, in addition to any other tax deduction you already receive for your contribution.

> Qualifying income ceiling limits for the Retirement Savers' Tax Credit increased in 2011 to \$55,600 for joint filers, \$42,375 for heads of household, and \$28,250 for singles or married persons filing separately. Consult IRS Form 8880 for more information.



very pleasant distinguished man in the third chair. My recollection was he was a great and sympathetic listener."

Charlie Purich

"Ritual to get a haircut there. There were usually two barbers and back then you would request who you wanted. (And wait for that barber.) Mr Comte specialized in brushcuts and he had this special goo he would add after the cut was done. Kept your brush cut on end for at least a few days.

"Also recall the board they would place across the seat for young patrons. Can't recall too many c o n v e r s a t i o n s between the patrons or barbers because the shop was a sombre place--you went there for a haircut or shave-period. Not too many smiles--just business!

"The shave was a hot towel affair and then out came the straight razor. Glad I didn't have whiskers back then!

"Back then you could get a haircut, have a milk shake at the Model Grill, get a mickey at the LCBO and play a game of pool upstairs at the pool hall, all in the same hour!!!"

David McMillan on Mr. Lucas

"Right off the top of my head I remember his chair was the one closet to the window and when he was in the process of giving you a haircut he'd forever be waving as people walked by on the sidewalk. I was also fascinated by the shaving procedure ... the head over the sink, the towel wrapped around the face and the straight razor that

he periodically used to hone its edge."

Merrick Goldstein

"One Sunday my dad (J.G. 'Jiggs' Goldstein) decided to give me a haircut cause mom had been given a pair of little hand clippers. I don't remember how old I was but old enough to realize what a poor job he had done. I waited on the step of the barber shop before school til Mr. Comte opened up and told him what had happened. As I recall, Mr. Comte in a very polite manner suggested that my father should not quit his job at Collins Store."

Dr W.R. "Bill" Pellow

"The barber shop had changed drastically by the time I was going there for my monthly haircut. Different from the pioneering days when I was a boy going not to Brownlee's barber shop but to Comte's barber shop. . In the early days when Mr. Comte would have just arrived in Chapleau the barber shop was the transitional shop that was frequently used by the lumberjacks.

"My Dad relayed the stories that the lumberiack would arrive in town after a full winter in the bush and head directly to Smith and Chapples and buy "birds eye" Mackinaw pants, new knee length boots and socks and new shirt head to the barber shop where he had a hair cut, a steam towel hot shave and shampoo and in the back room there was a tub where he could bathe. He cut the bottom 12 inches off his pants and was supplied brown paper to wrap his old clothes in and he changed into a clean shaven respectful citizen. This package of old dirty clothes were burnt in a barrel in the back yard. Then he headed next door and remained in the bar and stayed drunk, until he was broke. Then headed back to the lumber camp to sign on for another season. A small sad circle of frivolity and waste. Truth or fiction.

"As a young boy I always wanted Mr. Comte to cut my hair. He was a gentile man and always of even temperament. His chair was the furthest from the front door. Herb Lucas's chair was next to the window where he could wrap on the window with his comb with one hand and keep on cutting with the other. Then there were two more chairs that were manned by the "transient " barbers.

"Mr. Comte

had a muscle ball on his right forearm that was created by hours of using the scissors with his arms elevated. He always cut your hair as you wished, or as directed from afar by your parents.

"During the war years he could be found each Friday in the basement of the town hall playing his violin accompanied by Mrs. Stancil (Pellow) Rose on piano and Jim

Broomhead on sax. The music was music of a generation past but a delight to dance to. An orchestra to dance to even a three piece orchestra was a treat for any Chapleau teenager.

"It is amazing how one small statured man can bring back memories of a life time ago, memories of deportment, dignity, grace and talent." My email is mj.morris@live.ca



Ontario Weather Review: February 2011

February 2011 was a normal month for most Ontario locations in terms of mean temperatures and precipitations.

Mean temperatures did not stray from normal as the majority of areas remained seasonal. A few exceptions were Elliot Lake, which experienced colder temperatures than normal and Petawawa which experienced warmer

temperatures than normal.

Several storm systems traveled through the south of Ontario this month, resulting in seasonal to above seasonal snowfall and total precipitation amounts. London and Muskoka received almost twice the snowfall amount normally expected for February. Windsor received over three times the normal snowfall amount. For total precipitation Windsor received more than normal, while Kingston received less. Northern Ontario has received low to seasonal snowfall and precipitation amounts, with the exception of Moosonee that received more precipitations than normal.

Severe Weather February started off with a bang as a strong low pressure system moved northeastward from the Central United States into Eastern Canada. The system brought general accumulations of 15 to 25 centimetres of snow over a two day period to parts of southern Ontario, with locally higher amounts. With strong northeasterly winds forecast, in addition to low visibility due to snow and blowing snow, a blizzard warning was issued on February 1 for regions extending from Hamilton to Sarnia the first time a widespread blizzard warning had been issued in southern Ontario since March 1993. Unlike the midwestern United States, where some areas received in excess of 50 centimetres of snow, snowfall amounts in southern Ontario did not attain the forecasted 30 to 40

roads.

A second low pressure system moved through the Windsor – London area days later creating whiteout conditions throughout the region. The London Airport reported 17.5 centimetres of snow on February 5.

In Kenora, temperatures rose 15 degrees Celcius above seasonal values, and in southern Ontario, the warm air mass broke single-day high temperature records. A strong cold front followed the warm air on February 18 bringing wind gusts of 80 to 90 kilometres per hour throughout southern Ontario. Fallen trees, power outages and structural damage were blamed on the gusty wind conditions. In some areas near Barrie, blowing snow resulted in the Ontario
