CHARGES LAID IN BREAK, ENTER & THEFTS – On February 23, 2009 members of the Chapleau OPP executed a search warrant at a Chapleau residence in relation to a Break and Enter investigation reported at a cottage near Chapleau. Approximately \$5000.00 worth of property was stolen and extensive damage had been done. As a result of the search a substantial amount of property and two insecure firearms were seized from the residence. Investigation has lead to a 20 year old and two 19 year old Chapleau residents being charged with Break and Enter, Mischief and Possession of Property Obtained by Crime. Further charges were laid against two of the accused males of Break and Enter regarding another incident which had occurred in 2007 as well as a theft of an outboard motor in 2008. One of the males has been charged for firearms related offences in regards to unsafe storage. All three will be appearing in Chapleau Court at a later date to answer to the charges.

Motor Vehicle Collision – On February 27, 2009 at 4:50 pm a two vehicle MVC at Sean Court in Chapleau resulted in minor damage and no injuries. Two vehicles exiting their driveways at the same time came into contact with each other. No charges were laid as a result.

Theft - Chapleau OPP are presently investigating a theft from a local residence. Missing is a substantial amount of Canadian \$1 and \$2 coins. The theft is believed to have occurred between February 25, 2009 and March 1, 2009.

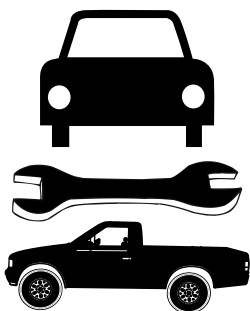

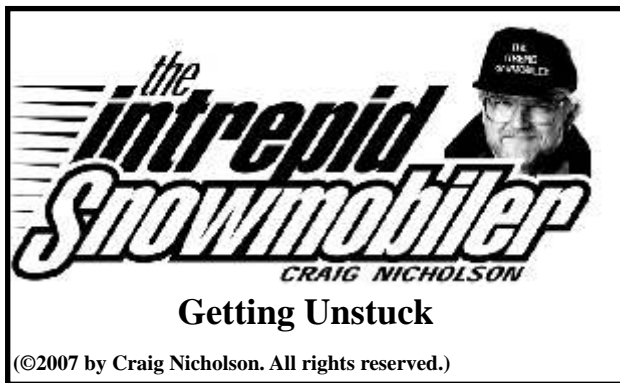

With today's great trails and sleds, getting stuck doesn't occur as often as it used to, but it still happens. By stuck, I mean buried so badly you need a crane for extraction. Even the lightest sleds can seem immovable as a rock when they sink into that deep stuff, usually thanks to a moment's inattention by the rider or letting off the throttle at precisely the wrong instant. And even with a group of strong buddies available, getting unstuck can be a sweaty, exhausting chore.

So what if you're on your own? Don't get me wrong, I don't mean riding alone — a total no-no. I mean if those with you can't help, due to age, affliction, lack of strength or not being able to get to you. Last winter, I witnessed two such situations and here's what happened...

Scenario #1: While searching for the trail after a huge dump of snow, one rider followed what could have been the path, but it quickly led him into deep powder. About five hundred yards in, he got buried. Every one of us knew that any sled going to help would get stuck too, and with the snow more than five feet deep, walking to him wasn't an option either. Enter Plan B...

First, he tipped his sled on to one side and scooped out the snow from under one running board so that the track could touch bottom freely. Then, he repeated the process on the other side. Leaving that snow to settle a bit under the track, he swam to the front of his sled and slithered on his belly like a seal in front of it for about 20 feet, to pack the snow down...and then repeated this action to widen his freshly broken path. Next, he swam

back to the front of his sled and packed the snow down under and around the belly pan and from around his skis. Then he sat down and rested whew!

About half an hour later, he repeated the whole process once again, compac-ting the snow even more, then waiting for it to set again. Next, knowing that he likely had just one shot to break free without getting re-stuck, he fired up his sled, gave it constant, steady throttle, and wiggle-wobbling his standing body from side to side on the running boards, worked his way out of that morass. A key factor in this process is ensuring that your sled is pointed where you want to go before you begin all that packing, so you are not attempting to turn as you start up.

Scenario #2: While high marking in the mountains, one rider got stuck way up a steep hill when he lost forward momen-tum as the back of his sled sank into the powder. So his sled's pointed uphill and none of us could get up to him. The trick is to get the sled out without the downhill force of gravity grabbing it when it's pointed the wrong way...that could result in a barrel roll the whole way down.

First, he assembled the shovel that all mountain riders carry in their backpack and used it to dig out a flat shelf in the snow on the slope beside his skis. Next, he went to the uphill side at back of his sled and dug out another shelf. When this was deep and wide enough, he tugged his skis around on to the front shelf and then heaved the back of his sled on to the rear shelf. Now his sled was positioned horizontally across the slope, but on a flat area so it would not flip over and roll down. After a hard-earned rest, he excavated more shelf

on the uphill side at the back of his sled and pulled it his track around on to it, so that the sled was now turned mostly with the skis facing back downhill. Then he

mounted up, started up, and rode down like a screaming banshee! Not bad for more than an hour's back breaking effort.

The morale of

this column: avoid getting stuck, but if you do, make sure your burial site is very close to many willing and able friends! Until next time, the Ontario

Review of Long Term Management Direction Spanish Forest 2010 – 2020 Forest Management Plan

We Need Your Input

Do you...

- Have an interest in the natural resource management of the Spanish Forest?
- Want to know more about the proposed long-term management direction of the Spanish Forest?
- Want to take an active role in the planning process and development of the Spanish Forest Management Plan?

If you answered yes to any of these questions, the **Ontario Ministry of Natural Resources (MNR), Domtar Inc.** and the **Spanish local citizens committee** invite you to review the proposed long-term management direction for the 2010 -2020 forest management plan (FMP) for the Spanish Forest. The proposed long-term management direction includes the proposed management strategy, which will provide for sustainability of the Spanish Forest by balancing social, economic and environmental considerations, consistent with legislation and policy.

You will have the opportunity to review and comment on:

- Levels of access, harvest, renewal and tending activities;
- Preferred harvest areas and areas which could be reasonably harvested during the ten-year term of the plan;
- The analysis done of alternative corridors for each new primary road for the next twenty years.

Your comments and input will help us develop balanced and well informed decisions as we continue with the planning process. Any additional background information that you can provide us with would be greatly appreciated.

How to Get Involved

A summary of the long-term management direction, which includes a map summarizing proposed harvest areas and primary road corridors, has been prepared and is available for review on request. As well, "value maps", which provide information such as fish and wildlife habitat features (e.g., lake trout lakes, heronries), parks and protected areas, tourism facilities as well as many other features of the Spanish Forest are available on request.

Comments on the proposed long-term management direction for the Spanish Forest must be received by Paul Leale of the planning team at the MNR Espanola Area Office, by April 3, 2009.

A summary of all comments collected throughout the planning process will be made available to the public in a summary form during the planning process and for the duration of the approved ten-year plan.

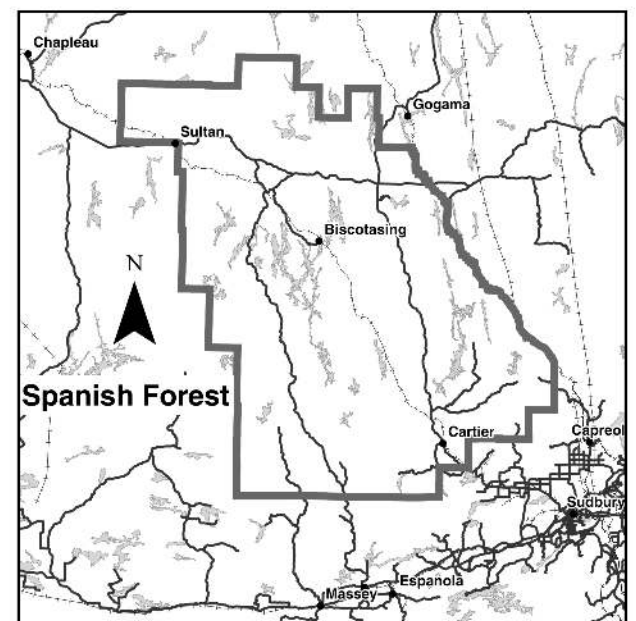

Ontario Weather Review: February 2009

For many, February was a pleasant change from January. Instead of the bone-chilling values seen last month, this month brought somewhat above-normal temperatures across the province. In Northwestern Ontario, and in spots in eastern Ontario, temperatures were two to three degrees above normal. The rest of the province

reported values closer to normal.

Precipitation-wise, there were only a few areas of unusual reports. The snowfall reported in Ottawa and Wiarton were the

lowest amounts since the late 1990s.

Severe Weather

The expected thaw in January never really materialized for most of Southern Ontario. However, this month there was a stretch of mild weather, from February 7-12. During this mild spell, the large amounts of snow on the ground that had accumulated in many areas disappeared in a number of locations. Frozen ground, plus a significant amount of rain caused by a system that moved through Southern Ontario on February 11-12, combined with the snowmelt to cause flooding issues in a number of localities. Because the ground was frozen, there was no capacity to absorb all of the water, and so it

quickly flowed into local rivers and streams. The warmer temperatures were another complication. These caused previously frozen rivers to begin to break up and form ice jams, which compounded the flooding issues in some areas. By the end of the thaw, most regions in Southwestern and South Central Ontario – excluding the traditional snowbelt areas near Lake Huron and Georgian Bay – had little in the way of snow left on the ground.

The month wrapped up with a significant mixed-phase storm that moved out of the American Midwest on February 26 and then proceeded to drive through Lake Huron and Georgian Bay on February 27. Warm air that was

pushed northward by the storm caused significant rainfall from the areas to the east of Georgian Bay in through the upper Ottawa Valley. Storm totals of between 10 and 20 millimetres were recorded. As well, periods of freezing rain were reported in the North Bay through to the Algonquin Park area. From Sault Ste Marie through to the Chapleau, Greater Sudbury and Temagami areas, the event was mostly snow, with accumulations ranging from 10 to 20 centimetres. The storm system pushed off into Quebec during the day on February 27 – but not before strong, gusty winds from the north caused plummeting temperatures throughout Central and Southern Ontario.

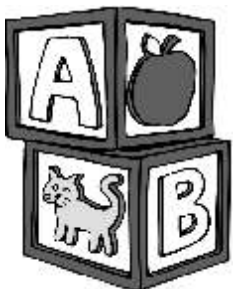

Snowmobile fatalities continue to rise in Ontario

(ORILLIA, ON) - The Ontario Provincial Police (OPP) is concerned with the increase in fatal snowmobile incidents so far this season. The number of related deaths investigated by the OPP has risen to 17 from the high of 13 last year to this point in the season.

The repeated causes of these tragic deaths have been constant and predictable. Either alcohol or excessive speed has played a direct role in nearly every fatal crash investigated by police.

"The result means that 17 people have died since December that had some measure of control over the circumstances that led to their senseless deaths" said Larry Beechey OPP Deputy Commissioner for Traffic Safety.

"Our communities need to act with us." stated Chief Superintendent Bill Grodzinski Divisional Commander for the OPP Highway Safety Division (HSD). "The vast majority of recreational snowmobilers are law abiding people. We all have a role to play to ensure the safety of everyone who enjoys this winter activity. Most of these crashes occurred when the operator was with someone else. That means someone else condoned the risky behaviour or the use of alcohol while on the trails" said Grodzinski.

Sergeant Michael Price, Off Road Safety Coordinator for HSD states, "Do your part to keep everyone safe on the trails. Call your local police and report the operators that continue to make poor decisions while riding."

Snowmobilers are also asked to stay away from lakes and rivers. Mild temperatures and occasional heavy snowfalls have left many bodies of water snow covered but still unsafe for snow-mobile travel.

OPP SAVE Teams (Snowmobile, All terrain and Vessel

Enforcement) and detachment snowmobile patrol officers strongly urge snowmobilers to enjoy their sport by sticking to maintained trails and riding responsibly. Drinking and riding is a criminal offence. Being convicted will result in the suspension of your driver's licence and



worse, potentially can lead to serious injury or death. Recent snowmobile deaths are a tragic reminder of that.

The proposed long-term management direction also includes the proposed management strategy, which will provide for sustainability of the Gordon Cosens Forest by balancing social, economic and environmental considerations, consistent with legislation and policy.

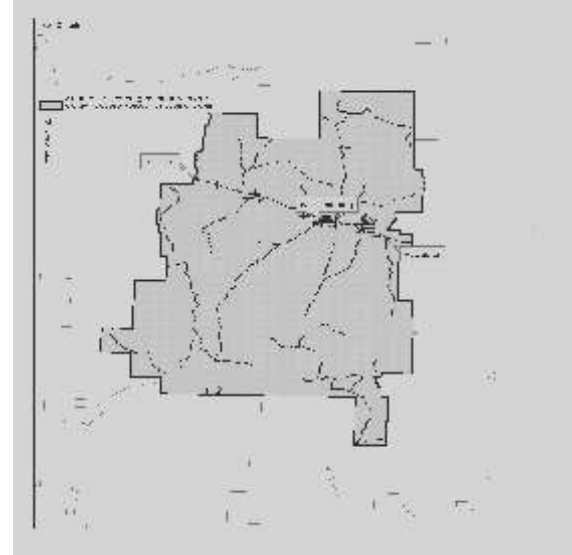
At this stage of the planning process, your comments on the proposed long-term management direction, in general, will be appreciated. More specifically, we want your comments on the preferred harvest areas and areas which could reasonably be harvested during the ten-year period of the plan, and the analysis we have done of alternative one kilometer wide corridors for each new primary road which is required for the next 20 years. Your review and comments will help us make balanced, well informed and fair decisions as we continue with the planning process. Additions that you can provide to the background information, previously made available, will also be appreciated.

A summary of the long-term management direction, which includes a map summarizing proposed harvest areas and primary road corridors, has been prepared and is available for review on request. As well, maps, with information such as fish and wildlife habitat features (e.g., lake trout lakes, heronries), parks and protected areas, tourism facilities as well as many other features on the Gordon Cosens Forest are available on request. These maps, known as "values maps", will be useful for anyone with a general or specific interest in this management unit.

Comments on the proposed long term management direction for the Gordon Cosens Forest must be received by Lauren Quist of the planning team at the MNR Kapuskasing Area Office by April 3, 2009.

Protect your assets - draw up a will

As the saying goes – where there's a will, there's a way.

A will is the best way to protect and transfer your assets, according to Chartered Accountant Jamie Golombek, CIBC Private Wealth Management in Toronto.

That is, if you even have a will. Many Canadians don't – and even if they do, it is often out-of-date with family circumstances.

"A will is the linchpin of any estate plan, and it can be simple or complex depending on the situation. It is a legal document that obliges your representative or executor to follow your instructions regarding how you want your estate distributed. It covers two key areas – the distribution of your property and assets, and the care or guardianship of any minor children."

Team Approach

Professional advice is critical in designing a will.

Chartered Accountant Vinay Khosla, Tax Principal with Fuller Landau LLP in Toronto, recommends a team-based, multi-disciplinary approach.

"Consult a team of professionals, including a Chartered

Accountant, lawyer, insurance agent and investment adviser, who will work with you to determine how to accomplish your objectives in the most effective way.

"While your will must be legally effective and able to stand up to a court challenge if necessary, it should also be tax-effective. Too simplistic an approach can create serious tax problems, particularly if you own shares in a private corporation. The biggest mistake people make is assuming their estate will owe no tax by transferring their capital property to their spouse upon their death, on a tax-deferred basis."

If both spouses die simultaneously, legislation stipulates that at the death of the second spouse, all capital property is deemed to be disposed of at fair market value. Even though the estate may not have cash sitting in its bank account, on the death of the second spouse, the estate must still pay taxes on any unrealized capital gains, such as shares in a company. If that company is private, the estate may face liquidity

problems.

Tax Strategies

"To plan for these issues, first determine the extent of your tax liabilities on death," continues Khosla.

"Your CA will help you review your assets and quantify both the income tax implications and probate fees payable on death. With a number to work with, you can then begin your planning."

Depending on the size of the estate, there are various strategies, including purchasing life insurance to fund the liability. Another strategy involves implementing a corporate reorganization known as an estate freeze, which allows you to effectively freeze the capital gain at the effective date of the freeze, passing the assets' future growth (and taxes on that growth) to the next generation.

Testamentary Trusts

Golombek explains that a will provides the unique opportunity to set up a testamentary trust – a type of trust that is created upon death, through the will.

"A testamen-

tary trust is the number one missed opportunity in estate and tax planning. One advantage is that it protects inheritances. In many situations, the estate is left to the surviving spouse – which can compromise children's inheritances if the surviving spouse then remarries, subsequently dies, and leaves the estate to the second spouse.

"A testamentary spousal trust avoids this outcome: some or all of the property is left to the surviving spouse in the trust; the spouse has access to the income from this property and, in some circumstances, the capital, and the assets transfer to the children upon death of the surviving spouse."

Another advantage is that a testamentary trust as a separate taxpayer provides for post-mortem tax planning and savings.


"With a trust, the surviving spouse has full access to the assets, but any income from

these assets can be taxed inside the trust, at the graduated tax rates. For example, if an income of \$123,000 is left to a high-income spouse, it is taxed in the spouse's hands at the top personal tax rate of 46.4 per cent. However, if it is taxed inside the trust and paid out as tax-free capital, the tax bill will be

significantly less – about \$16,000 less using 2008 rates."

"A word to the wise," says Khosla, "Don't wind up the trust. The assets must stay in the estate to reap the full tax benefits."


