was held on March 1st and the committee of elected, appointed and other volunteers, including parents, rolled up their collective sleeves and got right down to business in a wide ranging discussion on various youth oriented issues.

The meeting was a fulfillment of an election pledge at the November Municipal Election by Mayor Earle J. Freeborn who declared at the start of the meeting that he appreciated everyone's "commitment and concern about our youth."

Setting the tone at the outset the Mayor stated: "It wouldn't be

wise for us to tell them (youth) what we want to do for them." As the meeting progressed, it became evident the committee is determined to canvass the youth of the community to see what's on their minds. A survey questionnaire is being drafted for approval at the committee next meeting, with the intention of asking the schools for their cooperation in an effort to make direct contact with youth.

While the inaugural meeting of the new committee discussed a plethora of ideas centered on the requirements and desires of the

community's youth, their absence around the table was noted. "We have to address that right away," stated Councillor Keith "Bud" Swanson. It was suggested youth be invited to join the committee and participate in developing plans to facilitate their desires. Several ways to do this were discussed and plans for a direct approach are expected to be laid out at a future meeting.

In the meantime, the first meeting of the Youth Committee created a long list of possible projects.

Topics ranged

from a drop-in center to organized summer playground programs. Several of the parent committee members noted there are many sports activities for youth already and sometimes there are scheduling conflicts, especially during summer. Youth who are going to participate in sports are already involved. It was also acknowledged that when kids get to a certain age it is difficult finding things for them

The Drop-In Center for the youth appealed to some of the Committee members.

"They want to

hang out," said one Committee member, and herself a parent. "They need to be involved in the town. They need something to do," she added. There are people in town who want to help. The lack of volunteers to assist in any activities was viewed by some as an obstacle in future endeavors however; the meeting was optimistic in its view that there are people willing to get involved.

I would like to respond to the article which appeared in your paper on March 3, 2007 entitled, "Deputy Mayor booted out of meeting - Community once again left in the dark."

It is important for your readers to be aware that the meeting held with foster parents on March 01, 2007 in Chapleau was a private meeting. Those foster parents present were asked if the Deputy Mayor, local school principal, reps from MCTV, and the Chapleau Express could attend. The foster parents did not want these individuals to participate in this meeting.

By April of 2008, Kunuwanimano Child and

Family Services will hopefully become designated as a First Nation child welfare agency. Clearly, 85% of the cases served by our Chapleau office are First Nation children and it is in the best interests of these children that they be served by a First Nation CAS.

The Minister of Children and Youth Services, the Honourable Mary Anne Chambers, has gone on record that all children must be treated with sensitivity and with respect when it comes to their culture and heritage. The Minister is also committed to the re-allocation of funding to First Nation child welfare agencies and remains

a strong supporter for the legal and constitutional rights of aboriginal people.

On March 01, 2007 in Sudbury, the Board of Directors of the CAS of the Districts of Sudbury and Manitoulin discussed the concerns raised by Mayor Freeborn and they remain steadfast that service delivery to children in the Chapleau area will improve in the long term, with the

eventual transfer of child welfare services to Kunuwanimano. It is our hope that those in positions of authority and influence within the Chapleau community will rally behind Kunuwanimano, as they work towards this goal.

Approved 2007-2008 Annual Work Schedule for the **Superior-Martel Forest**

The Chapleau District of the Ontario Ministry of Natural Resources (MNR) has approved the Tembec Enterprises Inc. 2007-2008 annual work schedule (AWS) for the Superior-Martel Forest Management Unit. The annual work schedule will be available for inspection at the ministry's Chapleau District Office and Tembec Enterprises Inc.

Office (see address below) beginning March 15, 2007.

The AWS describes the forest management activities (e.g. road construction and maintenance, timber harvesting, renewal and tending) that are scheduled to occur on the Superior-Martel Forest between April 1, 2007 and March 31, 2008. These activities are consistent with the approved Superior-Marte Forest Management Plan.

The following are some of the operations that are scheduled on the Superior-Martel Forest that may be of particular public interest:

Commercial thinning is being conducted on a trial basis. Fuelwood is available for harvest on this management unit. A mapped summary of the scheduled forest management operations is available along with information on the location of fuelwood areas at the ministry's Chapleau District Office (see address below).

There are no prescribed burns planned on the Superior-Martel Forest during the term of the 2007-2008 AWS other than slash pile burning within recently harvested areas. Areas have been proposed for the aerial application of herbicides

Access control and road decommissioning activities are scheduled during the term of the 2007-2008 AWS.





jurisdictions that has opted to extend daylight savings time. Beginning this year, daylight savings time will now begin on the second Sunday in March, and end on the first Sunday in November. The extension means that daylight savings time will now start three weeks earlier than before, and end a week

The decision to move daylight savings time in Ontario was made in an effort to maintain the province's competitive advantage by coordinating the time change with our major trading partner, the United States, who recently adopted extended daylight savings time as well. The province looked long and hard at changing daylight

savings time, and an inter-ministerial committee was put together to look at the effect the change might have on trade, energy, public safety a n d more. Stakeholders and other levels of government were consulted on the change. Ultimately, a majority of stakeholders supported of the idea of ensuring our clocks were synchronized with those of our American neighbours.

The United

States has chosen to adopt extended daylight savings time in an effort to help conserve energy, as people are not expected to need their lights on as early in the evening. While there has been some debate as to how much energy this plan will really save, it is notable that Germany became the very first country to adopt the concept of daylight savings time in 1915 for much the same reason.

In Canada, it is

up to each province to decide whether or not to adopt a change to daylight savings time. In Ontario, daylight savings time is governed by the Time Act, legislation that is the responsibility of the Attorney General. Most of the provinces and territories in Canada have chosen to adopt the proposal to extend daylight savings time.

So this Sunday, do not forget to turn your clocks forward one

REPORT from **OTTAWA** by



STEPHANE DION COMMITS TO CORRECTING CANADA'S AFGHANISTAN **MISSION**

Liberal leader Stéphane Dion committed to Canadians in a recent speech that he would embark on a principled and constructive way forward on Canada's Afghanistan mission that would see a better integration of military and aid efforts as well as a firm 2009 end date. Mr. Dion began his speech by asking this question. Assume for a moment that we followed Mr. Harper's desire to have Canada

position he advocated in 2003. His judgment in that case has proven to be very poor. If we had followed Mr. Harper into Iraq, would we stay in that quagmire at any cost in order to support our troops? Obviously not. We owe it to Canadians, to the Canadian Forces and to the Afghan people to do our best today to ensure our mission in Afghanistan succeeds—for Afghans, for Canadians and for the international community.

During his speech, Mr. Dion outlined the key elements of the Liberal plan, including:

- Committing to end Canada's mission in Kandahar in 2009 and immediately informing NATO of this deadline so that a replacement nation can be found:
- Better integrating military, aid and diplomacy efforts:
- Developing an effective strategy to combat the problems stemming from the local economy's dependence on the illegal opium trade; and
- Addressing the chronic fresh water shortage.

Under Mr. Dion's leadership, the Liberals would retain the current number of Canadian troops in Afghanistan until 2009 to honour the international obligation undertaken by the Harper government, but would review the current mission and reserve the option of re-deploying Canada's combat task force to other under-resourced and critical functions in Afghanistan, such as

Ctraining the Afghan National Army and additional Provincial Reconstruction Teams.

Between now and 2009, the Liberals would adopt a more responsible, integrated strategy in Kandahar, with a greater

development and diplomatic thrust, and with a real effort to win the hearts and minds of the Afghan people, upon whom the mission's success hinges.

On Friday, February 9, 2007 in Sudbury, the Honourable Jim Prentice, Minister of Indian Affairs and Northern Development announced a FedNor investment of \$499, 965 to support the implementation a central library network server. This funding will be disbursed through Ontario

Libraries Service-North to libraries who are members of the Joint Automation Server Initiative (JASI).

The funding will be used to assist libraries in preparing to put their catalogues on the joint server and to purchase the required hardware. The joint server will enable public libraries across Northern

Ontario to electronically access and share library information and resources. This project will dramatically improve the way small Northern libraries serve their communities and residents. McGuinty Government Invests In Future Prosperity For Northern Ontario

Communities To Pursue Hosting Opportunities For Support Services

The Ontario government is helping communities across Northern Ontario investigate growth opportunities in the corporate support and shared services sector with assistance from the GO North Investor Program, Northern Development and Mines Minister Rick Bartolucci announced today.

"The McGuinty government is committed to supporting our northern partners as they investigate business and i n v e s t m e n t opportunities that will help to bring jobs and economic prosperity to the North," said Bartolucci. "We applaud the partnership among the North's major economic development corporations to pursue new investment on a pan-northern scale and to promote the competitive advantages of doing business in the North."

The Timmins E c o n o m i c Development Corporation, on behalf of the North's five major cities and in partnership with Ontario's North Economic Development Corporation, will receive nearly \$119,000 from the GO North Investor Program to investigate growth opportunities for the corporate support and shared services sector in Northern Ontario.

The **Ontario Ministry of Natural Resources (MNR)** has approved the 2007/2008 annual work schedule (AWS) for the Algoma Forest, located in the ministry's Sault Ste. Marie and Wawa administrative districts.

Public consultation has contributed to the development of the forest management plan for this forest, and therefore this process has not been repeated during the development of the annual work schedule. 
