Chapleau Metis Receive \$25,000 in Capacity Funding

The Chapleau Metis Council has received the first instalment of \$12,500 from the Provincial Govern-

ment for capacity funding. Two other instalments will follow in March 2010 bringing the total amount to \$25,000. The funding is part of the New Relationship Fund (NRF) which helps aboriginal communities and organizations across Ontario participate in meaningful consultations with government and the private sector. Since December 2008, 111 First Nations' communities, 27 Métis

communities and several urban aboriginal organizations received funding under the NRF program. A total of 250 projects have been funded.

Establishing a fund to provide resources and skills to aboriginal communities and organizations was a key recommendation of The Report of the Ipperwash Inquiry released May 2007. The fund was

developed with input from First Nation and Métis partners.

In order to receive funding the Chapleau Metis Council had to complete a lengthy application process and in addition council members had to attend mandatory training sessions and seminars in Timmins, Sudbury and Toronto.

Locally the New Relationship Fund is intended to

help build consultation capacity and expertise, allow the Chapleau Métis Council to participate in Government of Ontario and industry-related consultation processes in relation to lands and resources. and build and improve relationships between the Government of Ontario, First Nation communities and Métis communities.

The Chapleau Metis Council will be

spending the majority of the funding within the community of Chapleau. The main priority is to open an office in the downtown area and purchase the needed furnishings and equipment to make it functional. The remainder of the funding will go towards new consultation training initiatives for Metis citizens and covering the costs of the consultation process.

Moving to Chapleau in 1900 from Moose Factory by canoe and walking the shoreline

Chapleau Moments

Imagine deciding to move to Chapleau in 1900 and making the entire journey by canoe and on foot from Moose Factory to your new home.

That's exactly what contributed to a population increase to the fledgling community on the main line of the Canadian Pacific Railway as First Nations families made the journey and the opportunity for gainful employment in a new location. Writing in Chapleau Trails, edited by Dr. William R. Pellow, Ian White mentions many of these families who migrated, but I will just share some of his story in this column. Mr. White is the uncle of John "Charlie" White born and raised in Chapleau, who died on March 12, 2009, and I will give you details on how you may remember him below.

Mr. White writes in Chapleau Trails that his grandparents Stephen and Jane Potts left Moose Factory in 1900, stopped for the winter in Mattice and then stayed at the Brunswick House Reserve on Missanabie Lake before arriving in Chapleau. His mother was nine years old at

the time and with her older sister Barbara walked most of the journey by following the shoreline.

He explains that this was necessary because his grandfather had only two canoes and room for three people in each vessel along with the possessions they brought with them. In Chapleau they built a house on Aberdeen Street.

After settling in Chapleau, Mr. White notes that the Elders of the community became devout members of St. John's Anglican Church, but as some could not get out to attend services at the church, they gathered at homes for prayer and enlightenment. He notes that Esther (Sanders) Swanson was their self taught organist and choir leader on Sunday afternoons, and "their joy of singing could be heard in the neighbourhood."

At age seven Mr. White joined the choir of St. John's with Terry and John Way-White, David and Elbert Collinson, Lorne and John Woodard, Edwin Good, Jim and Keith Searle with Reginald Thrush as choirmaster.

"I remember my first morning, it was Easter Sunday 1927 and my grandpa was sitting near the entrance when we entered the church. I can still see his smile of approval..."

Mr. White also writes about the "Lower Town" hockey team and some of the famous First Nations players from the early years. "Bob Turner was the noted goalie. Tony Cachagee a fast skating forward. Mickey Linklater was called to play for Glace Bay of the Maritime League and Joe Wolotco, not of the First Nation but a member of the team was called to play for the Windsor Bulldogs of the Ontario Hockey League."

He also notes that his older brothers Donald and John (Charlie's father) and a cousin Oliver "Doc" Potts and the Corston boys and Mickey and Farmer Linklater competed in the town softball league, adding that Jack Shoup and "Bunt" Burrows shared umpire duties, "both of whom sometimes bore the brunt of sharp criticism."

Mr. White, who served in the Third Anti Tank Regiment of the Royal Canadian Army in World War II, shares much more of life in Chapleau and I encourage you to read it in Chapleau Trails but now I want to switch to remembering his nephew John "Charlie" White.

I received a message from David McMillan, who now

lives in Selkirk, Manitoba about a way in which we can remember Charlie.

David wrote that when Charlie died, Jean, his wife, and the family had intended to set up a Trust Account for a future Scholarship Fund in Charlie's name where individuals could make memorial donations in lieu of flowers. "In speaking with Jean recently, I've learned that the logistics of following that intended course of action are so overwhelming that the undertaking has unfortunately had to be abandoned.

"As an alternative Jean and the family feel that Charlie's second choice would have

been to have donations made in his memory to St. John's Anglican Church in Chapleau where, in his youth, Charlie was a member of the congregation. St. John's was also an institution with which he maintained a close tie and relationship until his untimely passing."

Donation acknowledgements (excluding monetary contribution amounts) will be forwarded to Jean by

St. John's as they are received, and formal receipts for Income Tax purposes will, regardless of the amount contributed, be mailed out to donors in January 2011.


Thanks to Ian White, a member of one of Chapleau's pioneer families for sharing their story to give me a context to write about remembering Charlie, who I always thought was the star on the hockey team, to whom I once passed the puck and he scored, and who once told me during a road hockey game on the outdoor rink beside his home on Aberdeen Street, "You're pretty good."

Investing 101

It's been a year since I prepared my initial financial planning article for the Expositor. As we look back, I am pleased to see that markets have improved significantly, investor confidence is ever so slowly improving and interest rates continue to remain low. Knock on wood: the economic outlook appears promising.

That being said, we must utilize the recent downturn as a reminder to ensure that we continue a disciplined savings strategy that fits with our retirement objectives and timeframe. This means investing in both good and bad times.

As we all begin to (hopefully) generate dividends, interest and capital gains again, it would be useful to revisit some of the more tax-efficient places to invest your hard earned dollars.

RRSP's have generally served Canadians well. In

addition to providing immediate tax savings, the tax-free growth results in a much larger value than would be the case where the same funds are invested outside of the RRSP. Unfortunately, for individuals not generating much income and/or needing the funds for a short-term purchase (house downpayment/renovations, automobile, family vacation, etc.), RRSP's may not always be the vehicle of choice.

The Tax-Free Savings Account ("TFSA") officially went into effect in 2009 and, from a tax perspective, constitutes one of the most important savings vehicles since the RRSP. Similar to RRSP's, TFSA's permit tax-free growth of your investments. However, unlike RRSP's, withdrawals from TFSA's are not taxable (in a similar vein, contributions to TFSA's are not deductible). This makes them ideally suited towards saving for

short-term goals.


RRSP's and TFSA's should be used together and tailored to suit your own objectives and timeframes. For the investor that fully utilizes his RRSP room each year and has further cash to invest, use of the TFSA's is a 'no brainer'. Each individual is permitted to invest up to \$5,000/year into their TFSA. For those that have not contributed in 2009, you can make a total contribution of \$10,000 in 2010.

Once RRSP's and TFSA's are fully utilized, you should ensure that your mix of assets is appropriate. Very generally, investments generating interest and foreign income should be held inside your RRSP and TFSA while those yielding capital gains and dividends should be held personally. This is due to the fact that interest and foreign income are subject to a higher personal tax rates (as such, all the better for

them to grow inside your RRSP or TFSA). Often times you can 'swap' assets between your RRSP and your non-registered investments in order to accommodate the desired 'mix'.

Once you have dealt with the above, and you still have capital to invest (lucky you!), the use of insurance may be appropriate.

Depending on your age, health, income, etc., the purchase of an insurance policy can yield lucrative returns. This

is due to surpluses inside your insurance policy also growing tax-free. If carefully structured, the insurance policy can be used as collateral to provide you a tax-free cash flow stream in retirement.

Without question, the markets will continue to be bumpy. However, long-term investing should continue to be pursued. In doing so,

your goal will be to keep as much of your investment earnings away from the Taxman as possible. Use of the tools described above will definitely assist you in that regard.

The Chapleau Enforcement Team is seeking two candidates to appoint as Volunteer Deputy Conservation Officers (DCO). The selected candidates will be required to enter into a written agreement and meet the required number of volunteer hours as identified by the Enforcement Policy. 



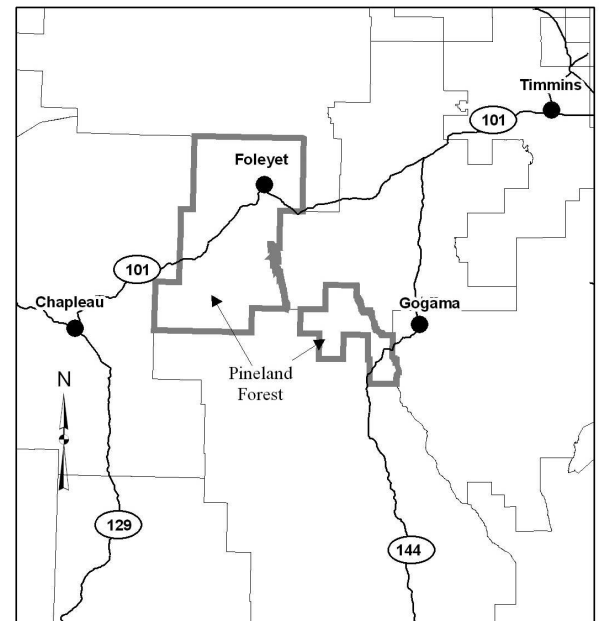

Changes affecting new home buyers

The provincial and federal governments have enacted changes in legislation that will affect new home buyers. The Ontario HST, announced

in the 2009 provincial budget and new mortgage rules, announced by finance minister Jim Flaherty on February 17th will play on the decisions

of the new home buyer. These changes will come into effect over the following months and new home buyers should understand how these changes will affect them and their purchase.

Newly constructed homes will be subject to the new 13% HST starting in July 2010. This will increase the purchase price of a home by 8% or an additional \$20,000 on a \$250,000 purchase. In order to alleviate the burden of this additional tax the provincial government has introduced an enhanced new housing HST rebate equal to 75% of the additional 8% tax. In my example this provincial rebate would be \$15,000 making the net increase in the

price of the new home only \$5,000 or 2%. The maximum rebate of the provincial component of the HST is \$24,000 and thus there is no additional provincial rebate on homes priced over \$400,000.

The federal GST rebate on new home purchases remains in effect for the 5% federal portion of the HST. This rebate is 36% of the GST or the federal component of the HST for new home purchases of up to \$350,000 and is gradually ground down to zero as the price of the new home increases to \$450,000. In my \$250,000 new home purchase example this rebate would remain at \$4,500.

We can see that the effect of the new HST will increase the price of a new home by 2% of the purchase price up to \$400,000 and 8% thereafter. If you are contemplating paying less than \$400,000 for your new home, the HST may not generate any significant additional costs but this may change as housing prices increase over time.

The new mortgage rules that come into effect on April 18th will require the new home buyer to meet higher qualification thresholds for servicing the debt. They will now have to prove that they can handle mortgage payments based on the 5 year fixed interest rate even if they are

looking for lower term and interest rate financing. This is up from the greater of the three year fixed or variable interest rate thresholds and this means that the new home buyer will have to earn an additional \$6,750 or \$10,800 annually to be able to purchase and finance a \$250,000 or \$400,000 home respectively.

If you are contemplating purchasing a new home it may be to your advantage to do so quickly before these two important changes come into effect and affect your ability to purchase the home of your dreams.

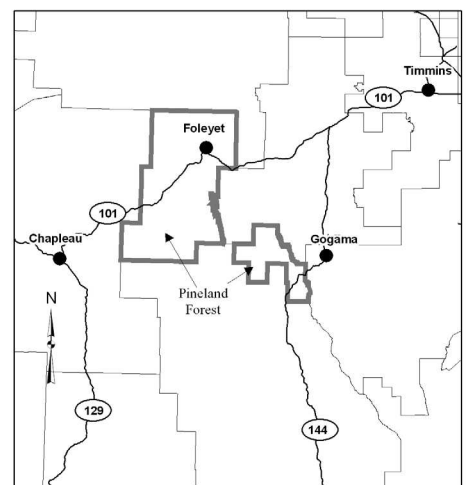

The things you learn through cancer...

(N C) — J o h n McCulloch, 40, is an up-beat and active individual whose passion for life and positive attitude is as inspiring as his story battling colorectal cancer. March is Colorectal Cancer Awareness Month and to raise awareness about the condition and inspire the thousands of Canadians that are affected by it each year, this is John's story.

S i n c e February 2008, John's life has been turned upside down by a

terrifying diagnosis of Stage IV, colorectal cancer that has spread to his liver and lungs. Since his diagnosis, John has gone through numerous chemotherapy treatments. He was originally treated with the most commonly used treatment, which was effective for eight months, however, his cancer eventually came back and he had to move on to new treatment options.

After several unsuccessful rounds of chemotherapy, John was tested for his

eligibility to receive a new class of biologic drugs that interfere with a common pathway involved in cancer spread called EGFr. In patients whose tumours have a mutation in a gene called KRAS, cancer cells continuously receive messages to grow and divide - these patients do not respond to anti-EGFr therapy. Luckily for John, his results showed that he was one of the 60 per cent of colorectal cancer patients who have the normal KRAS gene, making him a candidate for this new type of treatment.

“For patients with colorectal cancer it is important to detect the mutated gene so the right treatment can be prescribed. The results with new biologic treatments

can prove to be very beneficial to the patient, as was seen in John's case,” says Dr. Hagen Kennecke, medical oncologist and clinician researcher at the British Columbia Cancer Agency. “The decisions made by some provinces to include the medication in their health care plans, is a step in the right direction for cancer care in Canada.”

John was immediately put on a biologic agent with encouraging results. “Since being on this new biologic drug, my overall health is improving; the cancer levels are decreasing, my energy levels are rising, my appetite is coming back and today I feel better than I have in a long time” says John.

John's battle is

far from over, but cancer has taught him some valuable lessons both on life and on battling cancer. Not only is he now well-versed on the different chemotherapy treatments, their names and side-effects, but he also recognizes the importance of having access to the newest treatment options. Currently, less than half of Canadian provinces have included third-line treatments for colorectal cancer on the list of medications covered by provincial health care plans.


Most importantly, John has learned that a positive attitude and a passion for life are key in battling cancer. John continues to work at Best Buy Head Office, enjoys being surrounded by family and friends, and plans to travel for his spouse's upcoming 40th birthday. Cancer may have attacked his body, but it did not attack his spirit.

The 2010 Father's Day prostate challenge

(NC)—Father's Day is a time for the family to gather around and appreciate everything dad has done for them. But it's also a time for dads to think about what it means to be a father and how to be the best father possible. This year, do something different and give back to your family by giving the best present of all—you.

Prostate health is a major concern among men, especially those aged 40 and older. An enlarged prostate, known as Benign Prostatic Hyperplasia (BPH) is one of the most common medical condi-

tions to affect men today. As a matter of fact, by the time a man is 50 years old, he has a 50 per cent chance of suffering from the symptoms of BPH.

But the good news is that BPH and its related symptoms can be treated if caught early. By being proactive about your prostate health, not only are you protecting yourself but you're staying healthy for your loved ones as well.

The following steps will ensure a healthy prostate:

1. **Book your annual physical:** An annual physical is

supposed to be just that – annual. Routine tests can provide early detection of potentially life threatening diseases.

2. **Be prostate proactive:** Take time to learn the signs and symptoms of BPH so that you can take action immediately if you notice anything unusual. Most of the symptoms of BPH are related to urination and may include more frequent urination, inability to empty the bladder completely or a weak urine stream, and can be very uncomfortable.

3. **Get the tests:** A recent Leger

Marketing survey found that more than a quarter of men over 40 years old have never had a prostate specific antigen (PSA) blood test, and another quarter have never had a digital rectal exam (DRE) – the two main prostate health tests. Although it may be uncomfortable and embarrassing a DRE can detect BPH and ensure overall good prostate health. And it is recommended to get a PSA blood test at the age of 40 to get a baseline reading.

4. **Treat it early:** If you find that you do have a problem with your prostate, such as

BPH, talk to your doctor about treatment options. If not treated and treated properly by targeting the underly-

ing cause, the condition can progress leading to increased symptoms and possibly requiring surgery.

santé et de la maladie. Évidemment, les fournisseurs de soins de santé ne peuvent pas se comporter de la même façon avec tous les patients, car ces derniers ont des besoins différents et ils s'attendent à recevoir une attention « personnalisée ».

« Tous les gens ont le droit de recevoir des soins de santé qui conviennent à leurs préférences individuelles, ajoute Mme Coghlan. Toutefois, le patient pour qui cela est important doit communiquer ses besoins et ses attentes à son professionnel de la santé afin que ce dernier puisse en tenir compte. Plus le fournisseur de soins connaît bien son patient, plus celui-ci recevra des soins de qualité. »

Public Inspection of Annual Work Schedule

The Chapleau District office of the **Ontario Ministry of Natural Resources (MNR)** has approved Tembec 2010 – 2011 annual work schedule (AWS) for the Martel Forest. The AWS will be available for public inspection at the Chapleau District Office, the Chapleau Tembec Office and the Ministry of Natural Resources public website at ontario.ca/forestplans beginning March 15.

Scheduled Forest Management Operations

The AWS describes forest management activities such as road construction and maintenance, site preparation, tree planting and tending that are scheduled to occur on the Martel Forest between April 1, 2010 and March 31, 2011.

The Ministry of Natural Resources has reviewed the AWS to ensure that activities are consistent with the approved Forest Management Plan.

The following are some of the operations that are scheduled on the Martel Forest:

Commercial thinning is being conducted on a trial basis. Fuelwood is available for harvest on this management unit. A mapped summary of the scheduled forest management operations is available along with information on the location of fuelwood areas at the Ministry's Chapleau District office (See address below).

There are no prescribed burns planned on the Martel Forest during the term of 2010-2011 AWS other than slash pile burning within recently harvested areas. Areas have been proposed for the aerial application of herbicides.

Access control and road decommissioning activities are scheduled during the term of the 2010-2011 AWS.

Tree Planting and Fuelwood

Tembec is responsible for tree planting on the Martel Forest. Please contact Tembec for information regarding tree planting job opportunities.

For information on the locations of and license requirements for obtaining fuelwood for personal use, please contact the Chapleau District office. For commercial fuelwood opportunities, please contact Tembec.

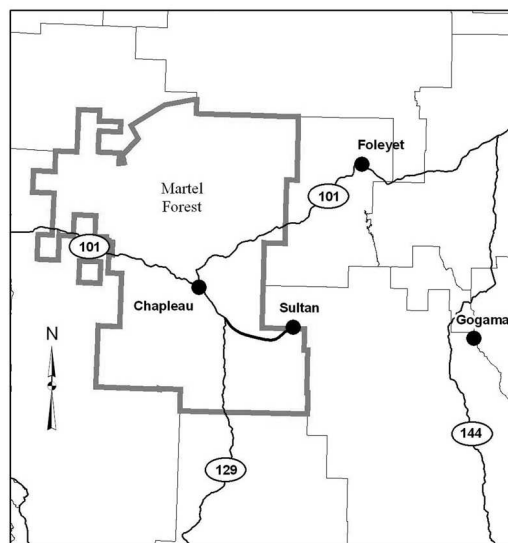
