## Sister with local roots chosen Superior General of her order



**Sister Réjeanne Roussel, Superior General of the Sisters of St. Mary of Namur.**

On July 24th, in Namur, Belgium, the Sisters of St. Mary of Namur, elected Sister Réjeanne Roussel as their Superior General. This is the first time in the Order's history that the post is occupied by a Canadian.

Sister Réjeanne went to primary school in the old Sacred Heart School in Chapleau which was operated by the Sisters of St. Mary who served our community for close to fifty years. She then went on to Ottawa to complete her secondary and univer-

sity studies.

In 1960, she entered the convent in this same congregation and in 1968, was sent to Africa as a missionary where she devoted herself for the next 37 years to education and guidance to young congolese nuns.

Sister Réjeanne would periodically return to Chapleau to visit her mother, Mrs. Lea Roussel, who passed away in January 2005 at Cedar Grove. Recently, Sister Réjeanne visited her sister, Mrs. Rita Mitchell who resides at 57 Pine St.

The Sisters of St. Mary of Namur are present in 10 countries: Belgium, England, Canada, United States, the Dominican Republic, Brazil, the Republic of Congo, Rwanda, Cameroon and Tanzania.

During her six

year mandate, Sister Réjeanne will reside in Belgium, while visiting the diverse communities that are involved mainly in education, youth pastoral, parish pastoral and the medical field.

Despite her numerous travels and journeys, Sister Réjeanne is always happy to come home to her birthplace in Northern Ontario and its friendly people.

Le 24 juillet dernier, à Namur en Belgique, les Soeurs de Ste Marie ont élu Soeur Réjeanne Roussel supérieure générale de leur Congrégation. C'est la première fois de leur histoire que cette fonction est assumée par une Canadienne.

Soeur Réjeanne a fait ses études primaires à

l'ancienne école du Sacré Coeur à Chapleau sous la direction des Soeurs de Ste Marie qui y ont oeuvré pendant près de 50 ans. C'est à Ottawa qu'elle a complété ses études secondaires et universitaires.

En 1960, elle entra comme religieuse dans cette même congrégation et en 1968, elle fut envoyée comme missionnaire en Afrique où elle se dévoua pendant 37 ans tant dans l'enseignement secondaire que dans la formation de jeunes religieuses congolaises. Elle revenait périodiquement à Chapleau pour rendre visite à sa mère, Mme Lea Roussel, décédée au Cedar Grove en Janvier 2005.

Dernièrement elle était chez sa soeur, Mme Rita Mitchell au 57 rue Pine.

La Congrégation des Soeurs de Ste Marie de Namur est aujourd'hui présente dans 10 pays: Belgique, Angleterre, Canada, Etats-Unis, République Dominicaine, Brésil, République du Congo, Rwanda, Cameroun et Tanzanie. Au cours de son mandat de 6 ans, Soeur Réjeanne résidera en Belgique tout en visitant ces diverses communautés impliquées principalement dans la tâche de l'éducation, la pastorale -jeunesse, la pastorale paroissiale et le domaine médical.

Malgré ses nombreux déplacements et les périples qu'elle devra encore effectuer, Soeur Rejeanne est toujours heureuse de retrouver son village natal dans le Nord de l'Ontario et sa population si attachante.

# While changing your clocks, change your smoke alarm batteries

CNW-The Ontario Fire Marshal is urging Ontarians to change the batteries in their smoke alarms when they change their

clocks this weekend.

"When Ontarians change their clocks, they should treat themselves to new smoke alarm batteries," says Fire Marshal Pat Burke. "Only working smoke alarms can alert

people to fire and give them the precious seconds they need to safely escape. It is the law to have working smoke alarms on every storey and outside all sleeping areas."

In many fatal home

fires, the smoke alarms have not worked, often because the batteries are dead, disconnected or missing. Smoke alarms are essential to detecting smoke in the early stages of fire. Many people are alive today because they were alerted by their smoke alarms. So, when Ontarians

change their clocks on November 4th, they should also remember to change the batteries in their smoke alarms.

Smoke alarms should be tested monthly and replaced if they are more than 10 years old. Also, it is important that everyone knows what to do if a smoke alarm sounds.

# Money to help Forestry Sector needed, not GST cuts, says St. Denis

In response to the Conservative government's October 30th Fall Economic Update announcing cuts to the GST, Liberal Member of Parliament for Algoma-Manitoulin-Kapuskasing Brent St. Denis said that the government should instead be using Canada's large budget surplus to help the Forestry Industry prosper as well as focus tax cuts for low and middle income Canadians as economists suggest.

## Breast Cancer Awareness initiative raises funds

Thanks to the initiative of a receptionist at Aux Trois Moulins and the participation of many supporters, the Breast Cancer Awareness Foundation has received the sum \$610.00.

The beautiful pink afghan displayed in the motel lobby was crocheted by Tara O'Hearn who generously donated her valuable time. It

added that he is happy to see Minister Flaherty reduce income taxes to the 2005 levels put in place by the previous Liberal government and reduce corporate taxes as Liberal Leader Stéphane Dion has called for.

"In a time when the federal government enjoys a record surplus, the government should be focusing on the forestry crisis affecting many Canadians in Northern Ontario and across the country," said Mr. St.

Denis. "In the towns in my riding where mills are shutting down and thousands of jobs are being lost, residents do not need a GST cut. Rather, they want to be employed and be able to provide for their families."

In contrast, Liberal Leader Stéphane Dion has already committed to hold a National Forestry Summit to create a strategy that would ensure the forestry sector is economically sustainable for the long term, if elected Prime Minister.

"The development of a sustainable forestry strategy is instrumental to enhancing the Canadian forestry industry and protecting valuable jobs" St. Denis continued. "I am pleased that Stéphane Dion takes this issue very seriously and that he is willing to stand up for the forestry industry. It is obvious by his actions that Prime Minister Harper is not."

In 2006, Conservative Prime Minister Stephen Harper negotiated a Softwood Lumber Agreement with the United States that left \$1 billion in the United States to help American forestry

companies compete against Canada. The agreement also created an export tax that is higher than the U.S. duties, included anti-surge provisions that deprived the Canadian industry of its flexibility to deal with unexpected circumstances, abandoned all of Canada's international legal victories under NAFTA and the WTO, and encouraged other U.S. sectors to ignore trade rules.

# 2007 Ontario weather review

September 2007 finished on a high note this year... high temperatures, that is - in fact, record-breaking ones.

Normally, the end of the month is its coolest part, but this year daytime high temperatures were smashed province wide. Not only were daily highs surpassed by two to five degrees on September 25, but this also established the all-time record warm spell for this time of the year. There are rare occurrences of 30 degrees in October, but values of 31 to 34 degrees have never been reported so late in the year.

Overall, the continuing trends of warm temperatures this past summer are

also still continuing into fall. The monthly mean temperatures were above normal - in a number of cases, climbing two to three degrees above normal. The dry to drought-like conditions in Southern Ontario also persisted. Monthly rainfall amounts of 20 to 30 millimetres were reported in many locations, resulting in only a third - or even a quarter - of what is expected for this time of the year.

Ironically, Northern Ontario's precipitation situation was very different. Rainfall values of 40 to 90 millimetres above normal were reported in a number of locations across the north and Kapuskasing shattered a 24-year-old

monthly record for most rainfall.

## Severe Weather

September was a tale of two vastly different weather regimes. Southern Ontario enjoyed long periods under the influence of high pressure, which provided plenty of sunshine and above-normal temperatures. However, this same area of high pressure deflected a parade of low-pressure systems that rolled over Northern Ontario, bringing clouds and rain. On a few days during the month, places like Geraldton, Wawa, Kapuskasing and Moosonee saw soaking rains with embedded heavier showers and thunderstorms that

generated single-day rainfall accumulations in excess of 35 millimetres. In one two-day stretch, Kapuskasing received more than 110 millimetres of rain, with 49.4 millimetres falling on September 6 followed by a drenching 61.4 millimetres the next day.

With respect to significant thunderstorms, there were a couple of active days. The afternoon of September 11 saw thunderstorm activity over regions to the east of Lake Superior, with one of these storm cells producing a probable brief tornado in the Batchawana Bay area to the north of Sault Ste Marie. Fortunately, only minor damage

occurred what with peak wind speeds likely around 90 kilometres per hour, making this a Fujita Scale Zero event - the weakest type of storm on the Fujita wind damage scale. By that evening, strong thunderstorms had moved into Southern Ontario, bringing driving rain and gusty winds to a number of communities. There was also a possible funnel cloud sighting to the southwest of Cambridge and a number of trees were

knocked over or lost large branches in the community of Galt, south of Cambridge.

The passage of a cold front during the afternoon and evening hours of September 14 also brought some locally heavy rain and gusty winds associated with thunderstorm activity. # 2,500 Children and Youth Waiting for Adoptive Parents in Ontario

## November is Adoption Awareness Month

CNW/ - During Adoption Awareness Month, the Ontario Association of Children's Aid Societies (OACAS) and its member agencies remind Ontarians that more families are needed to adopt children and youth in care. In Ontario, approximately 2,500 Crown wards are ready for adoption and

continue to live in foster, kinship or group home care. Of these, 34% are children between 6-12 years of age and 20% are aged 13-18 years. "There are so many

children and youth in the care of Ontario's Children Aid Societies dreaming of being adopted," said Jeanette Lewis, Executive Director of the OACAS. "We need more families to adopt older children and youth, sibling groups and children of diverse culture and heritage."

Parents from diverse cultural backgrounds, single parents or same-sex parents are encouraged to consider adoption. Adoptive parents who have the capacity to adopt children with special needs, sibling groups or older children are also desired.

"The incredible privilege of having a wonderful family of five sons ages 34 to 48, and six fabulous grandchildren has totally enriched my life," said Bob Smith, a single parent and

adoptive father of five including three brothers. Smith, a retired businessman and Director of the Laidlaw Foundation, added, "for me, the immense rewards far outweigh the challenges of raising adolescent, young men who came into my life at ages 10 to 19."

Ontario's Children's Aid Societies (CASs) use a standardized home study assessment process and education program for families wanting to adopt: the Parent Resources for Information, Development and Education (PRIDE) training program and the Structured Assessment Family Evaluation (SAFE) program for assessing prospective foster, kin, customary care and adoptive families. Last year, Ontario's CASs approved more than

1,400 families as potential adoptive parents and placed approximately 800 children and youth in previously approved adoptive homes.

Ontario's CASs are always looking for permanent homes for children and youth of all ages and for the best possible match of parent and child. Many elements are taken into consideration to facilitate the adoption process such as the culture and heritage of the child and adoptive family, the potential relationship with the birth family and relatives, and the need for special health services and educational supports.

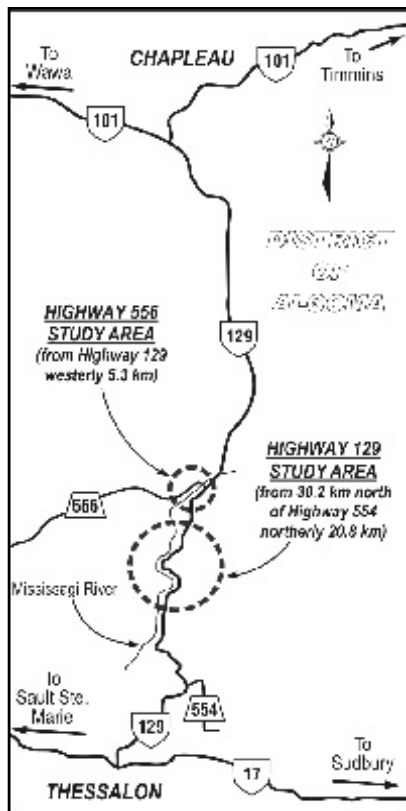

The Ontario Ministry of Transportation (MTO) is undertaking a Preliminary Design Study and Class Environmental Assessment (Class EA) for route selection and preliminary design for Highway 129 from 30.2 km north of Highway 554 northerly 20.8 km and Highway 556 from Highway 129 westerly 5.3 km in the District of Algoma as shown on the key plan. The study is identifying and evaluating new highway alignments and will recommend a preferred plan for the sections of Highway 129 and Highway 556 within the study limits. The firm of McCormick Rankin Corporation (MRC) is undertaking this study on behalf of MTO.

External agency and public consultation is taking place throughout the study, including two rounds of Public Information Centres (PICs). The first round of PICs was held in June 2007 and provided local residents and members of the public an opportunity to review the study process, the study need and justification, the Highway 129 and Highway 556 corridor alternatives, and the preliminary evaluation of the corridor alternatives.

Following the review of comments received at the first round of PICs, the Project Team has completed the analysis/evaluation of the corridor alternatives and route alternatives, and has identified the preferred plan for the two highway sections. The preferred plan includes design and operational improvements to Highway 129 and Highway 556. The improvements to Highway 129 will occur within the existing highway corridor within the study limits. A second PIC has been scheduled to review the analysis/evaluation of the corridor alternatives, route alternatives, and the preferred plan.

The PIC will be an informal drop-in centre in Thessalon. Representatives of MTO and their consultant will be in attendance to answer questions and receive comments. You are encouraged to attend the PIC and to provide us with your views and comments so that they can be considered as the study progresses. The PIC will be held as follows:

Peacekeeper Bill Unanimously Passes Report Stage

Brent St. Denis' Private Members' Bill C-287, An Act respecting a National Peacekeepers' Day is one step closer to becoming law. This week, the House of Commons unanimously accepted the Veterans Affairs Committee's Report on the Bill. It is hoped it will pass third reading in November where, if it passes, will be sent to the Senate.

The enactment of the Bill establishes a day to honour Canadian Forces peacekeepers every August 9th. On August 9th, 1974, nine Canadian Forces peacekeepers were killed when their plane was shot down by a

surface to air missile while en route from Beirut to Damascus. In total, 164 Canadian peacekeepers have lost their lives while keeping the peace around the world in over 66 nations.

"Now that my Bill has passed this important stage, I look forward to it becoming law. The intent of this bill is not only to recognize those in the armed forces who have sacrificed a great deal for peace and security around the world, but also to raise awareness in an increasingly dangerous world that

# More Foster Families Needed in Ontario

CNW/ - During Foster Family Week, the Ontario Association of Children's Aid Societies (OACAS) and its member agencies recognize families who give of their time and themselves by nurturing and fostering vulnerable children and youth.

"Foster families provide a precious gift to children in care. They share their love, their home and their family with our most vulnerable children," said Jeanette Lewis, Executive Director of the OACAS. "Foster Family Week is a good time to recognize those caring families who open their homes and their hearts to children who have suffered maltreatment and need a stable, loving home."

Last year, 58.5% of children in the care of Ontario's Children's Aid Societies were

placed with a foster family while 16.1% were placed in group homes, 4.4% with adoptive families, 5.3% with kinship families and 15.8% were living on their own. With 7,700 foster families in Ontario, there are still not enough homes available to provide temporary shelter to all the children coming into care who cannot remain with their families.

Since 2000, when neglect was added to the Child and Family Services Act, the number of foster families has increased only marginally (14%) while the number of children in need of protection increased 24%. More foster families who can provide safe, loving, secure homes to the vulnerable children who come into the care of Ontario's Children's

Aid Societies are needed. There is an urgent need for foster families for teenagers, as only 60% of all youth in care aged 13 to 15 years are in a foster family setting, and for younger children and sibling groups. There is also a pressing need for foster families from diverse backgrounds and ethno-cultural communities.

"Fostering brings caring and compassionate people and the kids who need them together," said Cecile Brookes, President of the Foster Parents Society of Ontario. "Fostering is a rewarding experience, a chance to make a difference one child at a time. We need more extraordinary people to consider becoming foster parents, to be a safe harbour to children and youth in need."

Ontario's Children's Aid

Societies work very hard to help children remain with their families. Last year, more than 44,000 Ontario families received child welfare services and parenting supports from a Children's Aid Society to cope with stress, poverty, addiction or mental health problems. When children cannot remain at home because of serious concerns about their safety and protection, they come into the care of a child welfare agency that makes every effort to give a family and a home to every child in need of protection. Last year, Ontario's Children's Aid Societies provided substitute care for 29,000 children.

Foster parents work closely with Children's Aid Societies to provide temporary care to children for a few

days, a week, several months or possibly years. They also prepare children for reunification with their biological family, adoption or long-term foster care. Children's Aid Societies support foster families through assessment, training and education, ongoing assistance as well as financial supports for the child's care, food and clothing.

The Ontario Power Authority (the "OPA") has filed an application with the Ontario Energy Board dated August 29, 2007 under the *Electricity Act, 1998*, S.O. 1998, c. 15, Sched. A (the "Act"). The applicant is seeking an order of the Board approving the Integrated Power System Plan (the "IPSP") and certain procurement processes. The Board has assigned file number EB-2007-0707 to this application.

The IPSP is a plan for the management of Ontario's electricity system. It identifies the electricity conservation, generation and transmission investments that the OPA proposes for the adequacy and reliability of electricity supply and demand management in Ontario. The procurement processes are designed to manage electricity supply, capacity and demand in accordance with the IPSP. The IPSP affects the supply of electricity to all Ontario consumers.

In developing the IPSP, the OPA was required to comply with the Act, the government's Supply Mix Directive and the Integrated Power System Plan Regulation. Under section 25.30(4) of the Act, the Board is required to review the IPSP to ensure that it complies with directions issued by the Minister of Energy and that it is economically prudent and cost effective. In addition, under section 25.31(4) of the Act, the Board is required to review the OPA's proposed procurement processes. The Supply Mix Directive, the IPSP Regulation, the Procurement Processes Regulation and relevant sections of the Act are posted on the Board's website under the IPSP link.

In addition to electricity conservation initiatives, the OPA has identified various electricity generation and transmission projects throughout the province that it is recommending be undertaken. These projects may affect your community. Maps and descriptions of the proposed projects are included in the IPSP.

The Board is seeking your views on what issues should be considered by the Board in its review. The issues list proposed by the OPA is available at the same locations as the IPSP.

This notice is Notice for phase 1 of the proceeding. Phase 2 will be the review of the evidence filed by the OPA and any other parties. The phase 2 notice will be published later, at the start of phase 2, providing details on how to participate in that phase of the proceeding.



**Tips to Avoid Phone and Email Scams**

These days, there is always someone thinking up a new way to get rich quick. One of the most popular ways to do this is through phone or email scams.

The best way to protect yourself is to know what to do if you have been approached by a scam artist.

There are some basic rules you should follow whenever you are dealing with any

organization by phone or email. Perhaps the most important rule of all is to never pay anyone in cash or provide them with your credit card number unless you are absolutely certain the organization in question is legitimate.

In some cases, these organizations may pose as charities. If you want to donate to a worthwhile charity, give to one that you know, or do some research into the charity

before you part with your money. Be wary of any situation that involves the use of high-pressure tactics, as any legitimate charity will gladly accept a donation at a later date. Unsolicited phone calls telling you that you are the "big winner" of a prize, or that someone needs

your financial help, are also likely to be scams. Be wary of any company who promises you a big prize in return for a minor purchase, even if they suggest the money is only needed to cover "expenses" for a prize. Also, be aware that investment scam artists will attempt to convince you to invest in progressively larger deals, before returning to tell you that all of your money was lost.

Be aware that any time you call a number with the area codes 1-900, 1-976 or 1-809, you are calling a number that you will be paying for. Often times, these numbers have a minimum charge of approximately \$35. While many legitimate businesses use these pay-per-charge services, these businesses will generally warn you about the fee up front. It is important to know that the promoter of numbers with these area codes receives a portion of money from each incoming call, and they will make efforts to keep you on the line for as long as possible. Also be aware that scam artists will often sell the names and numbers of people who have lost money to another scam artist.

When it comes to email scams, remember to protect your computer with up-to-date anti-virus and anti-spam software, as well as a personal firewall.

Only use your personal e-mail address when dealing with friends and family; set up a separate account for all other online activity. Do not open, respond to or make purchases from e-mails you suspect are spam – just delete them.

Be wary of any emails you receive from institutions, particularly banks, looking for your bank account, credit card number or other personal information online. Sophisticated scam artists will use phony but believable-looking emails to pose as institutions in order to acquire this information. If you have any questions, call the institution in question and inquire about the email before responding.

Always remember that signing up for mailing lists, replying to spam e-mail and posting your e-mail address can open your system to attacks.

Finally, if you are snared by a scam artist, do not be embarrassed. Come forward and help police capture the scam artist before they prey upon someone else.
