Under the leadership of Randal Desmoulin, National Native Alcohol and Drug Abuse Prevention worker for the Brunswick House First Nation community, partnerships are being established to celebrate activities during this week.

The Sobriety Walk is scheduled to take place in each participating First Nation community and within the Municipality of Chapleau. The

Chapleau route will start at the beach area between the Municipal Office and the Chapleau Public School. The Walk will proceed up Pine Street to Lisgar Street then on to Birch Street and down to Aberdeen Street and back to Pine Street and up Pine to Lorne Street to the Roman Catholic Church where hot refreshments will be served in the basement of the church.

As a community we need to stand together and show our solidarity to promote an addictions free lifestyle for our people. Addiction does not make a distinction between cultures, sex, age, or economic status. I urge our citizens to take part in this very important initiative. To date community



# Cenotaph moved to new site beside Legion in 1978, and Ladies Aid very active in 1947

## Chapleau Moments

In June 1978, a very moving ceremony was held to rededicate the cenotaph which had been moved from its original location beside St. John's Anglican Church, to its present site beside the Harry Searle Branch No. 5 of the Royal Canadian Legion Hall. Newcomers to Chapleau and many younger people may not know that at one time the cenotaph had another home.

The ceremony conducted by branch president Henry Therriault opened with the singing of 'O Canada' and the hymn 'O God Our Help in Ages Past' by the Chapleau Community Choir. Rev. William Ivey, branch padre, then gave the scripture reading followed by the community choir singing the anthem, 'Mine Eyes Have Seen the Glory.' Mr. Ivey and Rev. Carson

Duquette then delivered prayers of thanksgiving.

The cenotaph was then unveiled and Mr. Ivey gave a prayer of dedication while Air Cadet Morris played Last Post and Reveille. Cenotaph guards were Ken Russell and Lou Casconette. Branch president Therriault then laid a wreath, followed by others at the foot of the cenotaph in its new location. Legion members who were on parade deposited their poppies.

Led by the Chapleau Town Band, Legion and Air Cadet members went on parade around town, followed by visits to the cemeteries for a dedication of the graves of veterans.

Last week I shared some of the events of Remembrance Day 1947 and the election of officers to Branch No 5 for 1948. But most important in the history of this branch has been the tremendous work of the Ladies Auxiliary, called the Ladies Aid to the Canadian Legion in 1947.

At its regular meeting in December 1947, a past president Mrs. L. Montgomery installed the new executive for 1948. Mrs. Chas. Collings was president, Mrs. J. Robinson past president, first vice president Mrs. George Desson, second vice president Miss Josephine Way-

White, secretary Mrs. E. Chambers, treasurer Mrs. George Hunt (my grandmother), sergeant at arms Miss Lois Holding. The executive committee was Mrs. Louis McKee, Mrs. Earle Freeborn and Mrs. Florence Saunders.

After World War II, the Ladies Aid was very active and had just held its very successful Armistice Day Tea in the Legion Hall. As I was researching this column,

and came across the names of those involved in the tea, I had so many memories of those years after the end of World War II when I was just a child and the involvement of the Legion ladies in the life of Chapleau. I recall dropping by some teas to get some goodies as both my grandmothers would be there. I think I may have even had a cup of

tea!

Here is part of a story from the Chapleau Post about the tea. Pouring tea were Mrs. C. Saunders, Mrs. F. Depew, Mrs. G. Hunt and Mrs. Schroeder. The tea table had a lace cloth and was centred with a large bouquet of poppies. Those assisting in filling the plates were Mrs. Blackburn, Mrs. Steed, Mrs. Wm. Creighton, Mrs. C. Collings, Mrs. Ed Riley. Helping in the kitchen were Mrs. M. Riley, Mrs. C. Law and Mrs. Lauder.

Serving the tables were the following: Dorothy Bain, Joyce Chambers, Marlene Swanson, Beth Freeborn, Patricia McKee, Jenny Thompson, Betty Zufelt, Anne Zufelt, Dorothy Robinson and Mrs. A. Chambers. The sewing table was under the supervision of Mrs. L. Montgomery and Mrs.

Cochrane while the fish pond (my favourite place) was supervised by Mrs. E. Carroll, Mrs. J. Galey and Miss L. Holding. Receiving the visitors were Mrs. E. Chambers and Mrs. J. Robinson.

In my next two columns on November 21 and 28, I am pleased to advise that there will be a two part series on the 1966-67 championship Chapleau Junior "B" Huskies as told to me by Keith 'Buddy' Swanson, the manager of the team who had to take over as coach when Lorne Riley became ill. Buddy, who devoted much of his life to Chapleau hockey and is a former township councillor graciously took the time to answer my questions. It is a great story.




## NEWS RELEASES



# November is Diabetes Month

November is Diabetes Month and so along with our recipe we have included a few suggestions to consider for general healthy eating. As the weather outside gets colder, we tend to gravitate to cozy, comfort foods. Sometimes our baking can taste delicious but not be very nutritious; leaving us to feel guilty if we eat it very often. This recipe is packed with good stuff so you can incorporate them into your everyday fare with confidence.

### BLUEBERRY OAT BRAN MUFFINS (Anne Lindsay's "New Light Cooking" pg. 241)

|            |  |

| 1 cup      | oat bran (found in hot cereal section of grocery store)        |
| 1 cup      | whole wheat flour  |
| 3/4 cup    | wheat germ   |
| 1/2 cup    | packed brown sugar   |
| 2 tsp.     | baking powder  |
| 1 tsp      | baking soda  |
| 1/4 tsp    | salt   |
| 1-1/2 cups | blueberries (fresh or frozen)<br>Grated rind of 1 medium lemon |
| 2          | eggs   |
| 1-1/2 cups | buttermilk or soured milk*                                     |
| 3 Tbsp     | vegetable oil  |

1. Lightly grease or spray nonstick muffin pans with nonstick cooking spray.
  2. In large bowl, stir together oat bran, whole wheat flour, wheat germ, brown sugar, baking powder, baking soda, salt, blueberries and lemon rind.
  3. In separate bowl, lightly beat eggs; stir in buttermilk and oil. Pour over dry ingredients; stir just until combined.
  4. Spoon into prepared pans. Bake in 400 degree F oven for 20 minutes or until tops are firm to touch. Makes 12 muffins.
- (Store in airtight container for up to 2 days or freeze for up to 1 month.)



\*Substitution tip: if you don't have buttermilk, you can substitute soured milk. Place 1 Tbsp lemon juice or vinegar into measuring cup. Add milk to the 1-1/2 cup level; let stand for 10 minutes, and then stir.

These muffins are high in fibre. Increasing the fibre in our diets is a good idea for the majority of folks. For people with diabetes it can assist in the control of blood sugar levels. The added fibre will reduce the speed of and degree to which the blood glucose climbs after the food is eaten. For those who want to lose weight and consume fewer calories, the higher fibre foods will help you feel full longer. If cholesterol is an issue, increasing your fibre intake will lower the unhealthy cholesterol levels. Fibre has been linked with reducing the risk of heart disease, diabetes, obesity and certain types of cancer. It can help prevent high blood pressure and keep you regular.

The Ontario Energy Board (the "Board") received an application on October 14, 2009, under section 78 of the Ontario Energy Board Act, 1998, S.O. 1998, c. 15 (Schedule B), seeking approval for changes to the rates that Chapleau Public Utilities Corporation ("Chapleau PUC") charges for electricity distribution, to be effective May 1, 2010. The Board has assigned the application file number EB-2009-0219. The Board's decision on this application may have an effect on all of Chapleau PUC's customers. The application was filed under the Board's guidelines for 3rd Generation Incentive Regulation, which provides for a mechanistic and formulaic adjustment to rates between cost of service applications.

Any change to the rates that Chapleau PUC charges for electricity distribution will be reflected in the delivery charges. Delivery charges are one of four regular items on residential and general service customers' electricity bills and vary depending on the amount of electricity consumed.

Chapleau PUC indicates that if the application is approved as filed, a residential customer consuming 800 kWh per month would experience an approximate 0.5% increase in delivery charges. This is a \$0.16 per month increase on the total bill. A small general service customer consuming 2,000 kWh per month and having a monthly demand of 50 kW or lower would experience an approximate 3.3% increase in delivery charges. # Forest fire seasonal summary 2009

The Ontario Ministry of Natural Resources Aviation and Forest Fire Management Branch reports that provincially, the 2009 forest fire season was the second lowest recorded number of forest fires in Ontario in the past 50 years. The lowest year on record was 2008.

The total number of fires this season was 384, burning 20,656 hectares of land.

The 2009 fire season officially ended on October 31 and was close behind the 2008 forest fire season in Ontario which had 341 fires burning 1,316 hectares.

The ten year average number of forest fires in Ontario is 1,160 burning 108,337 hectares.

These low activity seasons are mostly the result of cool, wet weather which helps reduce the chance of fires spreading from outdoor fires that people set, and reduces the chance of

ignition due to lightning strikes.

The fire response system in Ontario is designed to expand and scale back according to the fire danger so it is always operating in an efficient manner.

As an emergency fire response resource for Ontario, as well as other prov-

inces in Canada and also the United States the ministry always has to be prepared to respond immediately to protect people, their property and industrial values. This requires maintaining a highly trained workforce and ongoing research and development to constantly improve fire response techniques and equipment.

Record setting levels of support to another fire jurisdiction were provided this year with dispatches of personnel and equipment to British Columbia which had a very active fire season from the end of July through to mid-September.

Just over 1,000 individuals from the ministry's aviation and fire program were involved including most of Ontario's FireRangers. Some had two deployments and a few were dispatched three times. A total of 21,605 person days of support were provided over a period of 67 days. This exceeds the previous largest dispatch of approximately 15,000 person days to Montana in 2000.

In a huge logistics effort, over 17,000 pieces of forest fire fighting equipment were packaged and transported to British Columbia and aviation services provided two CL-415 heavy water bombers.

While providing this level of support, Ontario preparedness levels were maintained to ensure adequate numbers of forest fire fighting staff and aircraft were positioned and that base support services and supplies/ equipment were ready to address any forest fire risk.

In another significant event,

FireRangers and support personnel provided assistance with clean up efforts in tornado and storm damaged areas around the communities of Vaughan and Durham as well as the resort area of Blue Mountain, Ontario.

Fire personnel and FireRangers also attended four major public events this year including the Toronto Sportsman's Show, the Toronto Cottage Life Show, the Ottawa Cottage Life Show and the Earlton International Plowing Match. They showed how the ministry's aviation and fire management program works and distributed FireSmart prevention information and showcased career opportunities.

Aviation Services continued its fleet renewal program with the addition of another EC130B4 helicopter this year, used during the season by the fire program. One of the long serving Bell helicopters was retired and has been subsequently sold to a private operator elsewhere in Canada.

On average, the aviation and fire management program expends \$119 million per year. Every year is different as a result of variability in fire occurrence and fire behaviour. Fire operating expenditures have ranged from \$65 to \$175 million annually over the past ten years.

The 2009 fire operational spending is approximately \$92 million, higher than the 2008 spending of \$85 million due to slightly more fires and significantly more hectares burned.

Preparations are underway for the 2010 forest fire season with equipment repair



# Forest fire seasonal summary 2009

and aircraft maintenance as well as staff training and upgrading.

## Regional Perspective

The West Fire Region recorded 194 fires with an area burned of 13,934 hectares and the East Fire Region recorded 190 fires burning 6,721 hectares during the 2009 fire season.

Of the number of fires in the West Fire Region, 104 of the

fires were the result of human activity with the careless use of matches and improperly managed recreational fires and residential fires such as grass and brush burning as the main causes. In the East Fire Region there were 71 fires caused by human activity with improperly extinguished campfires and grass and/or brush burning.

Lightning was the cause of 84 of the fires in the West Fire

Region and 37 fires in the East Fire Region while six fires in the west and eight fires in the east were classed as an unknown cause.

The quiet 2009 fire season provided an opportunity for ongoing proficiency training for the FireRangers, and research and development on firefighting techniques and equipment such as field testing operations in storm damaged timber was also done.

FireRangers from the East Fire Region and the West Fire Region, along with support personnel from each region, participated in the deployment of Ontario resources to British Columbia, first early in 2009 and then again from the end of July through to mid-September.

As well as being deployed out-of-province, FireRangers in the East Fire were



dispatched during the month of August to assist with tornado damage clean up in the areas of Vaughan, Durham and Blue Mountain. Those who assisted in southern Ontario spent much of their time in parks and woodlots clearing downed trees. Chainsaws and other support equipment were also provided by the ministry to support the clean-up effort.

FireRangers also spent time assisting Ontario Parks through various assignments.

The grand

witnesses on both sides of the debate, Canadians would have been short-changed. My hope is that the committee takes the time needed to hear from all interested parties instead of merely pushing it back to the House after one brief meeting – a fate that happens too often to Private Members' Bills.

Canadians have every right to be skeptical that this Bill will pass all the legislative stages needed to become law. If it is tied up at any stage and there is an election, effectively killing the Bill, the Conservatives will run with the registry as an issue again. The Liberals did this for years with child care.

What is worrying is that, while this

opening of the Hearst Fire Attack Base in the East Fire Region took place in September. This modernized base will help protect northern communities and the region's forest resources. The new office building and warehouse are strategically located to respond to fires in a large part of northern Ontario, including the Hearst, Hornepayne and Kapuskasing areas.

In addition, work continued on innovative projects in wildfire detection, forest fire suppression equipment testing and the development of green projects such as industrial composting to eliminate waste.

A group of Ontario FireRangers representing all wildland firefighters participated in the 2009 Canadian Fallen Firefighters Ceremony in Ottawa on Parliament Hill in September. This was the second year that Ontario FireRangers were in attendance.

Fire Management Head-quarters at districts within the West Fire Region reported the signing of fire response agreements with First Nations communities that will provide many benefits of partnership in forest fire management, and development of FireSmart initiatives as well as training and community involvement for years to come.

Work continued on reduction of storm-damaged forested areas through industry harvesting and a small prescribed burn. With thousands of hectares of storm and insect damaged forest in the region, the future risk of fire danger continues in the region.

Progress was also made on ecology-based fires in the region where some fires were monitored as they burned off storm and insect damaged forest. These fires were located within conservation reserves and parks or areas with fire response plans that recognize the benefit of fire as a way to restore natural ecosystems.

All such fires received a fire assessment and were monitored until they were declared out.

Fire personnel at districts across the region also provided interagency wildfire training to volunteer firefighters and municipal fire departments. They also worked with various organizations such as the tourist industry to deliver FireSmart messages. One of the ways that fire staff would deliver the FireSmart messaging was to have "Smokey Fridays".

Smokey and FireRangers would visit cottage country downtowns and hand out information on safe campfires and fire prevention.

The most recent vote on Canada's long-gun registry has sent a Private Members' Bill that will scrap the registry to committee. The Bill is the most straight forward legislation we have seen on the subject. Previous Private Members' Bills have been cloudy in their language and intent, and only served to confuse the issue for many people. What remains most curious is that the Conservatives have never once introduced a Government Bill on the subject which

would have allowed them to deal with this quickly. They seem to prefer the parliamentary games that keep the issue from actually being resolved.

I voted in support of sending the Bill to committee, as I believe Canadians deserve a full debate on the issue. However, the problem inherent with a Private Members' Bill is that it will only be debated for a few hours in the chamber of the House of Commons. If it did not go to committee for further study and testimony from

witnesses on both sides of the debate, Canadians would have been short-changed. My hope is that the committee takes the time needed to hear from all interested parties instead of merely pushing it back to the House after one brief meeting – a fate that happens too often to Private Members' Bills.

Recent mailings from the Conservatives, sent into predominantly rural ridings, were largely inaccurate and merely add fuel to the fire by pitting rural Canadians against urban ones. It is nothing short of playing games. Many believe the Conservatives do not really want to get rid of the registry, and why would they? It is a wedge issue that has served their American-

style, divisive politics very well. If it is ultimately scrapped they lose the goose that laid the golden egg. Canadians have every right to be skeptical that this Bill will pass all the legislative stages needed to become law. If it is tied up at any stage and there is an election, effectively killing the Bill, the Conservatives will run with the registry as an issue again. The Liberals did this for years with child care.
