A falconer with local roots helps in Sudan

Stephen Bucciarelli, owner of Predator Bird Services was in Sudan in August to help an experimental commercial farm that was established by the Canadian Economic Development Assistance for Southern Sudan.

The goal was to train local tribesmen to save their crop from marauding birds with the help of native falcons.

Bucciarelli was successful in catching and training native falcons to scare away small birds that are devouring the crops of corn and sorghum.

The main challenge was to train

the local people to become falconers and to ensure that they continue the job on their own. It hasn't been easy to convince people that the crops could be protected by trained falcons.

"They need a lot of direction - a lot of reassurance that they are doing it right. The real goal is to get them comfortable so they can do it on their own," Bucciarelli said.

The experimental farm established by CEDASS is the only large commercial farming operation in the nation and the grain fields are an easy target for thousand of birds.

"It's just like a giant bird feeder," Bucciarelli said.

Bucciarelli's

falcons chase the crop-stealing birds into nets where they are snared and end up in the cooking pots of the local tribespeople.

A family of baboons had recently moved close to the crop increasing the crop saving strategies.

Stephen Bucciarelli has been a falconer since he was fourteen years old.

Predator Bird Services uses falcons to chase birds from municipal landfill sites and at industrial sites such as the Bruce Power nuclear plant. Challenges aside, Bucciarelli said the Sudan mission has been the highlight of his falconing career.

Stephen Bucciarelli is a Graduate of the University of Western

Ontario, after studying Biology and Philosophy, and is a proud graduate of Mother Teresa Catholic Secondary School. He has been involved with political environmental issues in the City of London

since the age of 12 when he presented before City Council on a condemned habitat behind his home. Animals of all sorts have been a lifelong passion, and Stephen is now a licensed Commercial

Falconer, and President of the green corporation that professionally solves delicate wildlife problems.

Stephen is the son of Angelo and Doris (Delaney) Bucciarelli formerly of Chapleau.

The Emergency Transfer of C.P.S. to C.H.S...and Beyond

The Algoma District School Board, at its meeting on Tuesday, October 18, following the advice of senior staff, officially decided that the "JK-8 school community" at Chapleau Public School should be transferred, for safety's sake, to Chapleau High School.

Two days later, on Friday, October 21, a delegation from the Algoma District School Board came to Chapleau to see for themselves the alter-

tations to the high school building that were being contemplated in order to meet the needs of the elementary school students who will be arriving shortly -- refugees from the decaying core of their own school on Pine Street.

Parents and guardians of the Chapleau High School students (a group who until now have had the C.H.S. building all to themselves) were invited to attend an information-exchange over lunch with the

A.D.S.B. delegation at noon in the Chapleau High School cafetorium.

One parent and one grandparent showed up.

The chief spokesperson for the delegation from the Sault, Ms Asima Vezina, a Superintendent of Education with the A.D.S.B., said that there was a three-phase plan for dealing with the challenge of finding a permanent home to provide a stimulating and safe environment for



The truck and the trailer parked in front of Chapleau Public School last Friday confirm that the transfer of students, staff, and administration are indeed moving as quickly as possible up to the CHS building on top of the hill on the western edge of town. The proposed demolition of the public school on Pine Street will leave St. John's Anglican Church as the last historic building still on the Kebaquasheshing River. In the 1970s, the old Chapleau High School, the old Town Hall, the old Fire Hall, and the old Curling rink disappeared.

Re: Public School Structural Failure

Further to Mr. Evans and Miss Demers letters; she, and all who send their children to any publicly funded facility do so in good faith. The structural failure of this building should be interpreted as a wake-up call to the overall state of much of Canada's infrastructure – it is aging and most likely has a limited plan in place to maintain its overall life-cycle. No one likes increased taxes but that will be the only source of funds the School Board will have to correct the structural problems they will encounter throughout their governed region. Falling close behind are Ontario municipalities as their infrastructure is also significantly aging.

However, in this specific case, both Miss Demers and Mr. Evans ask who is responsible for the current state of this facility? In Ontario, all workplaces are governed by the Occupational Health and Safety Act (OHSA). The persons who enter the facility are protected by the Occupiers Liability Act. Both pieces of legislation dictate the role of the "owner" (School Board) in ensuring that

such areas are safe and serviceable; at all times. Had the failure resulted in a human injury the Ministry of Labour would have needed to be contacted to investigate the accident as Section 25 of the OHSA states: Duties of employer: An employer shall ensure that, (e) a building, structure, or any part thereof, or any other part of a workplace, whether temporary or permanent, is capable of supporting any loads that may be applied to it, (I) as determined by the applicable design requirements estab-

lished under the version of the Building Code that was in force at the time of its construction. Because there was no human occurrence it becomes the owner's responsibility to correct the issue and move on.

The role of all workplace parties under the OHSA is to strive to ensure the workplace is safe. The School Board under the OHSA must have and maintain a Joint Health and Safety Committee. Part of their responsibility is workplace inspections. There is no applied expectation that they are capable of confirming the structural integrity of the

building but they do have the right to request a copy of the most recent Engineers report on the condition of the facility – watch dogs of sorts to the day-to-day activities/conditions. Industry standards for a comprehensive structural engineer inspection for public buildings that are 90+ years old are no less than every 5-years however; many employers are failing to conduct such detailed reviews due to the associated costs of the inspection (the School Board may have an Engineer on staff?).

The School Board and its workplace parties are

responsible to ensure the building is safe and serviceable and the taxpayer is responsible to pay to maintain this level of safe operations. The real questions to be asked are – "when was the last time a structural engineers report was generated and what is the tabled plan for the overall life-cycle of the building" (often the reports are generated but no action on correcting the problems occur – should this be the case an injury would then possibly have a level of Negligence applied)? As a taxpayer you may also want to know what the "total estimated amount of unfunded capital liability is for

the region" (what the Board knows that needs to be fixed but they have no current funds to do it)? Those who took the time to vote for a School Board Trustee have the right to contact the Trustee to have these basic questions answered to their satisfaction. Those who did not vote continue to have the same right however, hopefully, their failure to engage in this democratic process this past go round will be corrected at the polls next election time as in the end it is all of us that is responsible for a safe community.

Chapleau Moments

The Rotary Club of Chapleau received its charter at a "mammoth" banquet in the Town Hall basement with over 100 Rotarians from all over Ontario attending to take part in the ceremonies in the Fall of 1951.

According to a newspaper report, they made their entry into town "in true northern style" with district governor Kenneth Partridge of Port Credit, Ontario, arriving on a dog sled driven by Adam Andrews of Chapleau. Other visitors arrived aboard a tractor driven sleigh.

Reeve B.W. 'Bubs' Zufelt and Councillor A.J. 'Art' Grout, both charter members who served as club presidents in 1956-57 and 1954-55 respectively donned chefs' attire to help

serve "the sumptuous banquet prepared by camp cooks."

Here is the menu which was really the talk of the town at the time. It included roast beaver, Manitoulin Island turkey, French Canadian pork pies, shanty beans, blueberry pies and rustic log cakes. The ladies of the Senior WA of St John's Anglican Church were responsible for serving the meal, and yes, to this day I remember it. I was 10, and had snuck down the back stairs of the Town Hall to see my grandmother Edith Hunt who was helping, and of course, she fed me.

The charter was presented to Rev. E. Roy Haddon, the club's first president by Mr. Partridge.

Rounding out the club's first presidents were Dr. G.E. Young in 1952-53, John 'Mac' McClellan in 1953-54 and Don Rose in 1954-55.

In 1964-65, Mr. Grout became the district governor, a high honour for Rotarians. It was a busy time for Mr. Grout as Engine 5433 arrived at its location in the park, and Mr. Grout was largely responsible for bringing it to Chapleau. N.R.

Crump, then president of the Canadian Pacific Railway was on hand for the ceremony marking the occasion.

Once established in Chapleau, for the next 60 years, the Rotary Club has been actively involved in community activities plus reaching far beyond its borders with programs. Here is just a glimpse at Rotary's work and some of the people involved. It is by no means complete but shows a continuing commitment to Chapleau and beyond.

The club become the sponsoring organization for the Scouts in Chapleau and still holds a land use permit for a camp at Gala Lake although there is no longer an active Scout group in the community.

For example, in 1970, at an awards night, tribute was paid to Scouter Manlio Spessot by group committee chair Rev. Murray Arnill, minister at Trinity United Church and Rotary president George L. Evans. Mr. Arnill commented that the "leaders of tomorrow" were being developed "under the capable leadership" of Mr. Spessot who expended "countless hours with the boys in leadership, counselling and outdoors programs".

Major awards were presented to scouts Peter Elliott and Dennis Paplinski in 1970. Both received the Pathfinder Award, the highest level of

achievement in Scouting.

The Chapleau club has been actively involved throughout its history Rotary's international exchange programs, bringing students from other countries to Chapleau as well as providing the opportunity for local students to travel. Presently it is also involved in a program to increase international understanding and good will whereby professionals from Korea, South Africa and Japan have visited Chapleau and vice versa.

A recent project has been the "adoption" of two kilometres of Highway 101 to keep it clean and it continues to improve the beach area.

Recently the club had 1300 wheelchairs to be unboxed and assembled before being distributed to needy children and adults in El Salvador.

For 60 years now the club has been involved in the life and times of Chapleau as well as participating in projects internationally. Congratulations and all the best for the future!

Chapleau's public elementary students.

Phase One was moving the elementary students as quickly as possible out of harm's way to the safety of the C.H.S. building. This phase, without much time for planning or for consultation, is now well under way.

Phase Two will be working the kinks out of these hasty arrangements to facilitate the amicable and mutually beneficial functioning of the two schools in the one building.

This phase will occur over the 2011-2012 school year.

Phase Three

will be a more thorough, unhurried search for a permanent placement of the public elementary school—a secure place where Chapleau's younger, public school students will grow and flourish. This stage will inevitably involve Ontario's Ministry of Education which holds the purse strings.

In Phase Three, serious consultation shall take place between the A.D.S.B. and those rate payers who support the Chapleau Public School system, the parents of students within the system, and the students them-

selves. So far the seriousness of the structural emergency at the C.P.S. building has not given the Board time to consult in a meaningful way with its clients and its tax supporters. That will not be the case with Phase Three. Phase Three is where there shall be ample time for discussions with the local stakeholders.

The choice will probably come down to opting either for making permanent the elementary and secondary schools' cohabitation in the same building on the hill or building a new building, more centrally located for the elementary students --or at least for JK to grade 6.

Preparing for a complete and interactive consultation with

the community of Chapleau will include a timely and multi-media notification of meetings and a scheduling of those meetings that will encourage the widest partici-

pation of the Chapleau public.

If the community is to be heard and have influence in the process envisioned for Phase Three, many more than one parent

and one grandparent must turn out to listen and to speak up. Otherwise the "consultation" will be a hollow farce played out in a room full of empty chairs.

A story circulated this week showing that young parents are facing a tougher time than their parents when it comes to the cost associated with raising a family. The heart of the problem is the fact that real salaries haven't moved much in

decades.

While it is true that the average family income has gone up quite a bit, the buying power it represents has barely budged. This is despite the fact that many more households now have two incomes, thanks to the

influx of women into the work force. Add in high youth unemployment and soaring student debt and we have a climate where the affordability of starting a family is losing its appeal. This is a big challenge which is made only tougher by the imminent retirement of the baby boomer generation.

Youth unemployment is a particularly tough nut to crack. The benefits of

higher education are not what they should be and there are many under-employed graduates in Canada. It is a worrisome trend that has at its root a society that values education, but does not adequately foster it. Whether that means helping students choose to study in areas that will be of benefit to the job market or employers recognizing that not all positions require under-graduate degrees - likely some combination of the two - the student debt cycle and underemployment crisis creates a lousy set of circumstances for many young Canadians.

What does the convergence of these societal indicators mean for Canada? It is time to do some

meaningful planning, just for starters.

We need to recognize that young families will be working hard to take care of the social infrastructure that the aging boomers will require, while also providing for their children. This leaves them stretched (in most cases) to the max and likely less able to prepare for their eventual retirement. There is a role the federal government can play in easing the burden facing young Canadian families. It begins by truly acknowledging the stress of these convergent trends and then developing appropriate policies to address them. Student debt requires a more creative answer than what we currently have. An industrial

strategy would help focus educators and guidance officers to encourage students into appropriate courses of study. And we must reverse the trend of piling taxes on the middle class and blue collar workers while providing a free pass to the wealthiest Canadians. In short, it is time to take stock of the very unlevel playing field and set about repairing that which is obviously in need. We are hearing more and more about the inequity of our circumstance from ever-divergent groups in our society. If left unaddressed, more young Canadians will chose to remain childless and the challenges that will present are considerable.

To all parents of the Public School and the High School:

I'd like to take a moment and thank all the Teachers Staff and Students for accepting the Chapleau Public School into their zone on such short notice. The safety of our children is #1.

Having two high schools, a public school, hospital, medical and dental clinic, all in the same location is going to be a very busy side of town. A public school is the heart of our community.

It's where parents will see their 4

year old child start school, the playground where they will play in and the classroom well suited for their needs. A public school is about youth and innocence, no peer pressure by far.

One parent from the Public School told me that their daughter said they had to buy new clothes for their new school. They had to dress a little older because they are going to be with the big kids now. 9 Years Old. Another parent told me, her 5 year old son said "You're not walking me to high school mom because it will be too embarrassing". 5 Years Old.

Our children are growing up too fast. They don't need to grow up any faster being at a high school.

High school student need their own space too. They need to grow into young mature adults, and find their own path in life being surrounded by their own age and mentored by smart high school teachers.

I have spoken to some high school students and they are not happy. They feel that they are being stripped from their high school years of maturing, growth, young adolescence and freedom from their public school.

Have you asked your child how they feel? If so, listen to them.

Apparently,

there are three phases to this plan:

-Phase One is here and gone - assessing the public school.

-Phase Two is happening now - moving to the high school.

-Phase Three - is what will be done with the public school.

Careless drivers on Halloween are the scariest monsters



(NC)—Trick-or-treaters, beware. The scariest place to be on Halloween isn't a cemetery or haunted house: it's on the road with an impaired or distracted driver. Safety experts warn that with so many children outside in the dark and many adults attending parties, the consequences of careless driving are

even more severe.

"Halloween is really the perfect storm," says Karen Benner, spokesperson for Allstate Insurance Company of Canada. "You have low light conditions, large groups of excited children in the street, adults who have been celebrating and drivers who may not be paying full attention."

dedicated designated driver for guests are great options," says Dubyk. "As a guest, make your feelings about impaired driving known—friends don't let friends drink and drive."

Parents can help keep their trick-or-treaters safe this Halloween by ensuring they are visible to drivers. Allstate

- Bring a flashlight with you;
- Make sure Halloween costumes and masks don't obstruct your child's vision;
- Stick reflective tape to shoes, gloves, costumes and candy bags;
- Stay close to your kids at all times and keep clear of the road.


